### A BILL FOR AN ACT

RELATING TO RESTORING RESPECT AND DIGNITY TO AMERICA'S ONLY ROYAL PALACE IN THE NATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that Iolani Palace is the

2 only royal palace in the United States in which a reigning

3 monarch lived and is an icon of the State. Iolani Palace should

4 be one of the State's most protected historical sites due to its

5 importance to the people of Hawaii, especially out of respect

6 for Hawaii's host culture and the Native Hawaiian people.

7 The legislature finds that the grounds of Iolani Palace

8 should be revered as highly as the Palace itself, and it is the

9 duty of the State to protect one of Hawaii's most historic and

10 treasured landmarks. Thousands of tourists visit Iolani Palace

11 annually, and many have noted that among the hundreds of royal

12 palaces worldwide, Iolani Palace is the only royal palace that .

13 contains metered parking within its grounds. The continual

14 desecration of the palace grounds as parking for state employees

15 and tourists is highly offensive and a misuse of the historic

16 landmark.

- 9 SECTION 5. (a) Commencing no later than January 1, 2026,
- 10 the department of accounting and general services shall remove
- 11 the blacktop, parking area, and paid public parking for visitors
- 12 and state government employees who do not work at Iolani Palace.
- 13 (b) Upon removal of the blacktop, parking area, and paid
- 14 parking adjacent to Iolani Palace, the department of land and
- 15 natural resources shall develop and maintain a pedestrian area
- 16 to replace the existing blacktop, parking area, and paid parking
- 17 adjacent to Iolani Palace, reflecting as much as possible, the
- 18 original palace grounds landscape as per photos from the Hawai'i
- 19 State Archives. The pedestrian area shall be composed of grass
- 20 or other historically appropriate materials.

### Report Title:

Iolani Palace; Parking; Prohibited; DAGS; DLNR; Report

#### Description:

Prohibits parking of motor vehicles on the grounds of Iolani Palace. Requires DAGS to remove the blacktop, parking area, and paid parking adjacent to Iolani Palace. Requires DLNR to develop and maintain a pedestrian area adjacent to Iolani Palace. Requires DAGS and DLNR to report on cost analysis.
