A BILL FOR AN ACT

RELATING TO TRANSPORTATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. Section 291L-1, Hawaii Revised Statutes, is
- 2 amended by adding a new definition to be appropriately inserted
- 3 and to read as follows:

- 4 ""Reviewing entity" means a county police department or
- 5 authorized employee of the department of transportation or
- 6 department of law enforcement."
- 7 SECTION 2. Section 291L-4, Hawaii Revised Statutes, is
- 8 amended by amending subsection (c) to read as follows:
- 9 "(c) Proof of a violation of section 291C-108 shall be
- 10 evidenced by information obtained from an automated speed
- 11 enforcement system authorized pursuant to this chapter. A
- 12 certificate, sworn to or affirmed by the reviewing [county
- 13 police department, entity, or a facsimile thereof, based upon
- 14 inspection of any clear and unobstructed photographs,
- 15 microphotographs, video, or other recorded images produced by
- 16 the system, shall be prima facie evidence of the facts contained
- 17 therein. Any photographs, microphotographs, video, or other

- 1 recorded images shall be available for inspection in any
- proceeding to adjudicate the liability for that violation."
- 3 SECTION 3. Section 291L-5, Hawaii Revised Statutes, is
- 4 amended by amending subsection (d) to read as follows:
- 5 "(d) Before mailing the summons or citation for a traffic
- 6 infraction pursuant to subsection (a), the [applicable county
- 7 police department | reviewing entity shall review and verify the
- 8 validity of the clear and unobstructed photographic, digital, or
- 9 other visual image of the license plate of the motor vehicle
- 10 required under this section."
- 11 SECTION 4. There is appropriated out of the general
- 12 revenues of the State of Hawaii the sum of \$ or so
- 13 much thereof as may be necessary for fiscal year 2025-2026 and
- 14 the same sum or so much thereof as may be necessary for fiscal
- 15 year 2026-2027 for the establishment and implementation of the
- 16 automated speed enforcement systems program.
- 17 The sums appropriated shall be expended by the department
- 18 of transportation for the purposes of this Act.
- 19 SECTION 5. Statutory material to be repealed is bracketed
- 20 and stricken. New statutory material is underscored.

1 SECTION 6. This Act shall take effect on July 1, 3000.
