A BILL FOR AN ACT

RELATING TO THE EXECUTIVE OFFICE ON AGING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that low-income subsidy 2 programs, including medicare, medicaid, and medicare savings 3 programs such as medicare part D extra help, can help reduce 4 out-of-pocket costs for individuals with limited income by 5 offsetting their medical and prescription drug costs, such as 6 premiums, deductibles, copayments, coinsurance, and lifetime 7 late enrollment penalties. The legislature further finds that 8 although individuals with low income, those who speak English as 9 a second language, or those who live in rural areas may gualify 10 for these programs, they may have no or limited access to the benefits, as they may not be aware of or need assistance with 11 12 the application or eligibility renewal process.

13 The legislature further finds that the Hawaii state health 14 insurance assistance program, administered by the executive 15 office on aging of the department of health, provides free 16 information and one-on-one counseling on medicare. Since 2022, 17 the program has been receiving a significantly higher volume of

referrals from med-QUEST to assist uninsured or underinsured
individuals who are losing their medicaid eligibility and need
to find other health coverage. The overflow and referrals are
made to community partners within forty-eight hours to help with
food, housing, utilities, employment, and other needs.

6 The legislature also finds that during the coronavirus 7 disease 2019 pandemic, the med-QUEST division of the department 8 of human services paused disenrollments based on eligibility 9 issues and all medicaid members received continuous 10 uninterrupted coverage through March 2023, regardless of their 11 change in eligibility. Following the 2023 Maui wildfires, the 12 med-QUEST division again paused all eligibility disenrollments 13 statewide until the end of 2023. However, the med-QUEST division has resumed its annual eligibility redetermination 14 process, and therefore, people have been or will be receiving 15 16 notices and forms to renew their coverage.

Accordingly, the purpose of this Act is to establish within the Hawaii state health insurance assistance program a temporary medi-medi project to assist the underserved population in the State who may qualify for various low-income subsidy programs to gain access to their benefits.

1	SECTION 3. There is appropriated out of the general
2	revenues of the State of Hawaii the sum of \$ or so
3	much thereof as may be necessary for fiscal year 2025-2026 for
