A BILL FOR AN ACT

RELATING TO VITAL STATISTICS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 338, Hawaii Revised Statutes, is
- 2 amended by adding a new part to be appropriately designated and
- 3 to read as follows:
- 4 "PART . COMMEMORATIVE CERTIFICATES OF STILLBIRTH
- 5 §338-A Commemorative certificates of stillbirth:
- 6 authorized. The department of health may issue commemorative
- 7 certificates of stillbirth; provided that the department has
- 8 previously filed and prepared a certificate of fetal death for
- 9 the registrant pursuant to section 338-9.
- 10 §338-B Fees. (a) The fees for a commemorative
- 11 certificate of stillbirth issued by the department of health
- 12 pursuant to this part shall be \$ for the first copy
- 13 and \$ for each copy issued thereafter.
- 14 (b) All fees received of remittances of commemorative
- 15 certificates of stillbirth shall be deposited into the vital
- 16 statistics improvement special fund established under section
- **17** 338-14.6.

- 1 §338-C Evidentiary character of certificates; absence
- 2 thereof. A commemorative certificate of stillbirth issued
- 3 pursuant to this part shall not be prima facie evidence of the
- 4 facts therein stated and shall have no valid legal standing as a
- 5 bona fide government record.
- 6 §338-D Disclaimer. The department of health shall print
- 7 on the back of every commemorative certificate of stillbirth
- 8 issued pursuant to this part a disclaimer in block letters in at
- 9 least twelve-point type that shall read:
- 10 "THIS DOCUMENT HAS BEEN ISSUED BY THE HAWAII DEPARTMENT OF
- 11 HEALTH AND HAS NO PRIMA FACIE EVIDENCE OF THE FACTS THEREIN
- 12 STATED AND SHALL HAVE NO VALID LEGAL STANDING AS A BONA FIDE
- 13 GOVERNMENT RECORD.""
- 14 SECTION 2. Section 338-14.6, Hawaii Revised Statutes, is
- 15 amended by amending subsection (c) to read as follows:
- 16 "(c) The fund shall consist of fees remitted pursuant to
- 17 section 338-14.5[-] and 338-B(b). All realizations of the fund
- 18 shall be subject to the conditions specified in subsection (b)."
- 19 SECTION 3. In codifying the new sections added by section
- 20 1 of this Act, the revisor of statutes shall substitute

- 1 appropriate section numbers for the letters used in designating
- 2 the new sections in this Act.
- 3 SECTION 4. Statutory material to be repealed is bracketed
- 4 and stricken. New statutory material is underscored.
- 5 SECTION 5. This Act shall take effect on July 1, 3000.
