A BILL FOR AN ACT

RELATING TO EMERGENCY EVACUATION ROUTES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the Waianae coast,
- 2 which encompasses communities from Makaha to Kahe Point, relies
- 3 predominately on Farrington highway as the area's sole access
- 4 route. This dependency on a single route poses significant
- 5 risks during natural disasters or accidents, when the ability to
- 6 evacuate quickly is critical. Recent studies and community
- 7 feedback have highlighted the inadequacy of the area's emergency
- 8 access roads, which fail to meet safety and capacity standards.
- 9 Notably, while a new emergency access road is scheduled to open
- 10 in Spring 2025, concerns remain regarding the road's capacity to
- 11 handle the traffic that would be involved in a large-scale
- 12 evacuation.
- 13 Accordingly, the purpose of this Act is to require and
- 14 appropriate moneys for the department of transportation, in
- 15 collaboration with the city and county of Honolulu, to assess
- 16 and develop an improvement plan for emergency evacuation routes
- 17 along the Waianae coast.

8	(2)	Develop a detailed plan to upgrade existing emergency
9		access roads, or to construct new evacuation routes
10		that meet established standards for road safety and
11		capacity, to enable residents from Makaha to Kahe
12		Point to evacuate quickly and safely;
13	(3)	Evaluate the feasibility of restoring and utilizing
14		unpaved roads, including the roads leading from
15		Waianae to Wailua via Peacock Flats and roads in the
16		Waianae Valley that were previously used by the United
17		States military; and
18	(4)	Engage with local residents to gather input and
19		address concerns related to the proposed evacuation
20		routes.

- 2 subsection (a), the department of transportation may request
- 3 input and assistance from the United States Navy.
- 4 (c) The department shall submit a report of its findings
- 5 and recommendations, including any proposed legislation, to the
- 6 legislature no later than twenty days prior to the convening of
- 7 the regular session of 2026.
- 8 SECTION 3. There is appropriated out of the general
- 9 revenues of the State of Hawaii the sum of \$ or so much
- 10 thereof as may be necessary for fiscal year 2025-2026 and the
- 11 same sum or so much thereof as may be necessary for fiscal year
- 12 2026-2027 to assess and develop an improvement plan for
- 13 emergency evacuation routes along the Waianae coast.
- 14 The sums appropriated shall be expended by the department
- 15 of transportation for the purposes of this Act.
- 16 SECTION 4. This Act shall take effect on July 1, 2025.
