### A BILL FOR AN ACT

RELATING TO ACCESS TO HIGHER EDUCATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that access to higher
- 2 education plays an important role in individual and societal
- 3 success. According to the College Board, there is a correlation
- 4 between higher levels of education and higher earnings for all
- 5 racial and ethnic groups, as well as both men and women. The
- 6 College Board has noted that the income gap between high school
- 7 graduates and college graduates has increased significantly over
- 8 time, while higher levels of education also correspond to lower
- 9 levels of unemployment, poverty, public health risks, and
- 10 incarceration throughout society.
- 11 The legislature further finds that in April 2016, the
- 12 Institute for Research on Higher Education at the University of
- 13 Pennsylvania Graduate School of Education issued a study that
- 14 analyzed college costs in relation to family income level. The
- 15 study revealed that while Hawai'i ranks high in college
- 16 affordability, higher education costs remain a major expense for
- 17 working families, especially those earning less than \$30,000

- 1 annually. The department of education also reported that the
- 2 college-going rate for the class of 2021 high school students is
- 3 fifty-one per cent, with Native Hawai'ian, Pacific Islander, and
- 4 Filipino students continuing to enroll in college at rates that
- 5 are lower than other ethnic groups.
- 6 Additionally, the legislature finds that the Hawai'i
- 7 community college promise program was established to alleviate
- 8 the high cost of obtaining a college education for low-income
- 9 families. Yet the program, along with other financial aid
- 10 policies, has not made community college fully affordable for
- 11 all students who wish to enroll in a community college.
- 12 Currently, the State provides minimal need-based assistance to
- 13 offset the unmet direct cost of community college for qualified
- 14 students enrolled at any community college campus within the
- 15 university of Hawai'i system, with the financial assistance
- 16 through the program contingent upon available funding and on a
- 17 greatest need basis.
- 18 The legislature also finds that some states have
- 19 implemented programs to make community college free for all or
- 20 most students, including California, Delaware, Nevada, New York,
- 21 Oregon, Rhode Island, Tennessee, Virginia, and Washington. The

1 legislature finds that expanding access to the Hawai'i community 2 college promise program to all qualified applicants would 3 increase Hawai'i's college-going rate, especially for students 4 and families who are economically disadvantaged. Expanding 5 access would also provide more students with the educational 6 opportunities that are necessary for the development of a 7 sustainable and diversified twenty-first century economy in the 8 State. 9 The legislature notes that the cost of making community 10 college tuition free can be estimated using data obtained from 11 the university of Hawai'i's institutional research, analysis, and planning office. For the fall 2022 semester, the university of 12 13 Hawai'i reported that 12,449 classified students with Hawai'i 14 residency were enrolled in community college, 4,930 of whom were 15 registered as full-time students and 7,519 of whom were 16 registered as part-time students. The university of Hawaii also reported that approximately forty-two per cent of community 17 18 college students received financial aid to cover the cost of

their tuition in the most recent year for which data is

available and that part-time residential community college

students enroll in 6.6 credits per semester on average. When

- 1 these data points are considered, the cost of making community
- 2 college tuition free for Hawai'i residents can be estimated at
- 3 less than \$20,000,000, even after accounting for first-year
- 4 enrollment increases experienced by other states that have
- 5 implemented free community college programs. Moreover, the
- 6 actual cost of making community college tuition free would
- 7 likely be even lower than these numbers suggest, since many
- 8 students received financial assistance from the military or from
- 9 other scholarship programs.
- 10 Accordingly, the purpose of this Act is to expand access to
- 11 higher education for qualified Hawai'i residents by:
- 12 (1) Expanding eligibility for scholarships under the
- Hawai'i community college promise program to all
- 14 qualified students; and
- 15 (2) Appropriating funds to finance the expansion.
- 16 SECTION 2. Section 304A-506, Hawaii Revised Statutes, is
- 17 amended by amending subsections (a) through (c) to read as
- 18 follows:
- "(a) Notwithstanding section 304A-501, there is
- 20 established the Hawaii community college promise program to be
- 21 administered by the board of regents. The program shall provide

5	(b)	[A] Each student enrolled at a community college
6	campus sh	all be eligible for [scholarship consideration] and

9	college p	romise program; provided that the student:
10	(1)	Qualifies for Hawaii resident tuition;
11	(2)	Completes and submits the Free Application for Federal
12		Student Aid for each academic year and accepts all
13		federal and state aid, grants, scholarships, and other
14		funding sources that do not require repayment;
15		provided that this paragraph shall not apply to a
16		student who enrolls in a certificate program;
17	(3)	Is enrolled in a classified degree or certificate
18		program with six or more credits per semester;
19	(4)	Maintains satisfactory academic progress, as defined
20		by federal requirements established pursuant to title
21		IV of the Higher Education Act of 1965, as amended,

1		and determined by the campus at which the student is						
2		enrolled; and						
3	(5)	Has been determined by the campus to have unmet direct						
4		cost needs.						
5	(c)	[Scholarships shall be awarded to the extent possible						
6	<del>based on</del>	available funds and on a greatest need basis.] An						
7	award granted to a student shall be equal to the student's unmet							
8	direct cost need, based on the Free Application for Federal							
9	Student Aid calculation of need, less the amounts available to							
10	the student from Pell grants and other scholarships; provided							
11	that the unmet direct cost need for a student who enrolls in a							
12	certificate program shall be based on a suitable instrument, as							
13	determined by the university of Hawaii, less the amounts							
14	available to the student from grants and other scholarships."							
15	SECT	ION 3. There is appropriated out of the general						
16	revenues	of the State of Hawaii the sum of \$20,000,000 or so						
17	much thereof as may be necessary for fiscal year 2025-2026 and							
18	the same	sum or so much thereof as may be necessary for fiscal						
19	year 2026	-2027 for expansion of eligibility for scholarships						
20	under the	Hawai'i community college promise program to all						
21	qualified	students.
