
A BILL FOR AN ACT

RELATING TO THE ENFORCEMENT OF FIREWORKS LAWS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the appropriations
2 provided in this Act constitute the State's share of the cost to
3 provide the services required pursuant to this Act and declares
4 that the appropriations are in accordance with Article VIII,
5 section 5 of the Hawaii State Constitution.

6 SECTION 2. There is appropriated out of the general
7 revenues of the State of Hawaii the sum of \$ or so much
8 thereof as may be necessary for fiscal year 2025-2026 and the
9 same sum or so much thereof as may be necessary for fiscal year
10 2026-2027 for four full-time equivalent (4.0 FTE) positions
11 within the Honolulu police department to enforce applicable
12 fireworks laws; provided that the department shall employ
13 effective means of enforcement, including, when appropriate:

14 (1) The use of unmarked vehicles and civilian clothing by
15 officers as they patrol neighborhoods; and

16 (2) The immediate issuance of citations.



1 The sums appropriated shall be expended by the Honolulu
2 police department for the purposes of this Act.

3 SECTION 3. There is appropriated out of the general
4 revenues of the State of Hawaii the sum of \$ or so much
5 thereof as may be necessary for fiscal year 2025-2026 and the
6 same sum or so much thereof as may be necessary for fiscal year
7 2026-2027 for four full-time equivalent (4.0 FTE) positions
8 within the Hawaii police department to enforce applicable
9 fireworks laws; provided that the department shall employ
10 effective means of enforcement, including, when appropriate:

11 (1) The use of unmarked vehicles and civilian clothing by
12 officers as they patrol neighborhoods; and

13 (2) The immediate issuance of citations.

14 The sums appropriated shall be expended by the Hawaii
15 police department for the purposes of this Act.

16 SECTION 4. There is appropriated out of the general
17 revenues of the State of Hawaii the sum of \$ or so much
18 thereof as may be necessary for fiscal year 2025-2026 and the
19 same sum or so much thereof as may be necessary for fiscal year
20 2026-2027 for four full-time equivalent (4.0 FTE) positions
21 within the Maui police department to enforce applicable

9 revenues of the State of Hawaii the sum of \$ or so much
10 thereof as may be necessary for fiscal year 2025-2026 and the
11 same sum or so much thereof as may be necessary for fiscal year
12 2026-2027 for four full-time equivalent (4.0 FTE) positions
13 within the Kauai police department to enforce applicable
14 fireworks laws; provided that the department shall employ
15 effective means of enforcement, including, when appropriate:

16 (1) The use of unmarked vehicles and civilian clothing by
17 officers as they patrol neighborhoods; and

18 (2) The immediate issuance of citations.

19 The sums appropriated shall be expended by the Kauai police
20 department for the purposes of this Act.



1 SECTION 6. This Act shall take effect on July 1, 2025.
