#### A BILL FOR AN ACT

RELATING TO SCHOOL BUS SERVICES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that this year reported a
- 2 historical bus driver shortage resulting in the elimination of
- 3 nearly eighty bus routes across the State. Amid driver
- 4 shortage, the department of education suspended a total of one
- 5 hundred and eight routes in Central Oahu and East Hawaii Island.
- 6 The suspension affected approximately 3,720 students. In
- 7 response, Governor Green expedited the approval of an emergency
- 8 proclamation to temporarily relax rules around the types of
- 9 vehicles that can be used to safely transport students to and
- 10 from school, and regulations around the required driver
- 11 certifications. The proclamation was signed on August 2, 2024,
- 12 and will expire on January 26, 2025. It is essential for the
- 13 governor's emergency proclamation to be codified to allow for
- 14 greater flexibility of school buses services and access for all
- 15 students.
- 16 The purpose of this Act is to:



1	(1)	Authorize the use of motorcoaches, small buses, and
2		vans for school bus services, provided certain
3		conditions are met;
4	(2)	Authorize the department of education to create a
5		staggered school start time program to mitigate the
6		school bus driver shortage to increase the
7		availability of student transportation for the 2025-
8		2026 school year;
9	(3)	Appropriate funds to the department of education for
10		the purchase of motorcoaches, small buses, and vans
11		for school bus drivers; and
12	(4)	Appropriate funds to the department of education to
13		incentivize obtaining a commercial driver's license,
14		to increase the number of persons eligible to become
15		school bus divers.
16	SECT	ION 2. Section 286-102, Hawaii Revised Statutes, is
17	amended by	y amending subsection (b) to read as follows:
18	"(b)	A person operating the following category or
19	combination	on of categories of motor vehicles shall be examined as

7		occupants, trucks and vans having a gross vehicle
8		weight rating of eighteen thousand pounds or less, and
9		autocycles as described in paragraph (2) of the
10		definition of "motorcycle" in section 286-2; and
11	(4)	All of the motor vehicles in category (3) and any
12		vehicle that is not a commercial motor vehicle.
13	A scl	hool bus, small bus, motorcoach, or van operator shall
14	be proper	ly licensed to operate the category of vehicles that
15	the operat	tor operates as a school bus, small bus, motorcoach, or
16	van and sl	hall comply with the standards of the department of

8	No exemption shall be granted for the qualifications of

11	(c)	The exemptions in subsection (b) shall be granted:					
12	(1)	To the department of education to administer to public					
13		schools based on criteria developed by the departments					
14		of transportation and education; provided that the					
15		department of education shall submit a report to the					
16		department of transportation at the end of each school					
17		year on the extent to which these exemptions were					
18		utilized;					
19	(2)	To a board of independent schools, which is registered					
20		with the department of commerce and consumer affairs,					

to administer to private schools utilizing criteria

1		developed by the departments of transportation and
2		education; provided that the board shall submit a
3		report to the department of transportation at the end
4		of each school year on the extent to which these
5		exemptions were utilized;
6	(3)	[Only for the transport of pupils to and from
7		school functions or school-related activities [but
8		$\frac{1}{1}$ , for transportation to and from a school[ $\dot{\tau}$ ], and
9		for transportation to and from designated drop off
10		locations and pick up locations established by the
11		department of education, in consultation with the
12		department of transportation;
13	(4)	Only when each pupil being transported has obtained a
14		written statement from the pupil's parent or legal
15		guardian waiving the State's liability; and
16	(5)	In accordance with the procedures and criteria
17		established by rules of the department of
18		transportation.
19	(d)	[The] Notwithstanding any law to the contrary, the
20	department	of transportation may grant exemptions for the use of

vehicles other than school vehicles [for the transportation of

1	students requiring special education and services], including					
2	the use of motorcoaches, small buses, and vans, for school bus					
3	services when the department of transportation finds that					
4	compliance with this section is impossible or impractical;					
5	provided that an adult staff chaperone provided by the					
6	department of education escorts students being transported					
7	between designated off-campus and designated on-campus					
8	locations; provided further that no exemption shall be granted					
9	for the qualifications of individuals driving a bus as defined					
10	in section 286-2 and such individuals shall meet school vehicle					
11	driver qualifications $[+]$ ; provided further that the use of					
12	vehicles other than school vehicles shall meet any applicable					
13	state and federal regulations.					
14	(e) The department of transportation shall adopt safety					
15	rules and standards relating to school vehicles, equipment, and					
16	drivers, including but not limited to:					
17	(1) School vehicle and school vehicle equipment design,					
18	construction, and identification;					
19	(2) School vehicle driver qualification and training as					
20	required by law;					

(3) School vehicle operation;

ı	(4)	School vehicle maintenance and maintenance records;
2	(5)	Special school vehicle safety inspections;
3	(6)	Criteria for passenger loading and unloading safety
4		areas; and
5	(7)	Procedures and criteria for the granting of exemptions
6		permitted under subsections (b), (c), and (d);
7		provided that the rules and standards shall permit the
8		use of small buses [or], vans <del>[weighing less than ten</del>
9		thousand pounds], or motorcoaches for the
10		transportation of pupils of a public or private day
11		care center, child care facility, headstart program,
12		[and] preschool, kindergarten, elementary, or
13		secondary school, including any special school for
14		children in the State with an accompanying adult staff
15		chaperone escort provided by the department of
16		education for students transported between designated
17		locations off-campus and designated locations on-campus
18		or of school pupils and school staffs to and from
19		school-related activities."
20	2.	By amending subsection (i) to read:

1	"(i)	As used in subsection (b), a school vehicle is
2	unavailab	le when it:
3	(1)	Is being used during a specific time for contracted
4		school-related transportation to and from school or
5		related destinations;
6	(2)	Fails that day's inspection and has not been repaired;
7	(3)	Is already in transportation service; or
8	(4)	Is committed for transportation service[; or
9	<del>(5)</del>	Does not meet the requests of a school for a
10		motorcoach with undercarriage storage compartments and
11		public address system; provided that the use of the
12		motorcoach shall be used solely for the transportation
13		of middle, intermediate, or high school student groups
14		to and from school-related events or activities. As
15		used in this paragraph, "motorcoach" means a vehicle
16		that carries more than twenty-five passengers, has a
17		gross vehicle weight rating of at least 26,000 pounds,
18		and is no more than fifteen years old]."

#### Report Title:
