A BILL FOR AN ACT

RELATING TO THE AGRIBUSINESS DEVELOPMENT CORPORATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the Waiahole water
- 2 system, also referred to as the Waiahole ditch irrigation
- 3 system, was constructed between 1912 and 1916 to irrigate
- 4 sugarcane fields on the western side of Oahu and consists of a
- 5 twenty-six-mile-long transmission system of ditches, tunnels,
- 6 siphons, and reservoirs that provides a source of irrigation
- 7 water to local farmers from the windward side of Oahu. The
- 8 system diverts approximately twenty-seven million gallons per
- 9 day from the windward to the leeward side of Oahu.
- 10 The legislature further finds that, in 1998, the
- 11 agribusiness development corporation was authorized to acquire,
- 12 administer, operate, maintain, and improve the Waiahole water
- 13 system to protect a vital natural resource and to ensure the
- 14 expansion of diversified agriculture in the State. As part of
- 15 the acquisition, the agribusiness development corporation was
- 16 required to reimburse the State for part of the acquisition
- 17 costs. This continued debt, however, burdens the corporation

- 1 and hinders its ability to maintain and improve the efficiency
- 2 of the system.
- 3 Accordingly, the purpose of this Act is to appropriate
- 4 funds to the agribusiness development corporation to offset the
- 5 financial burden of reimbursement of debt service.
- 6 SECTION 2. There is appropriated out of the general
- 7 revenues of the State of Hawaii the sum of \$ or so
- 8 much thereof as may be necessary for fiscal year 2025-2026 to be
- 9 deposited into the Waiahole water system revolving fund.
- 10 SECTION 3. There is appropriated out of the general
- 11 revenues of the State of Hawaii the sum of \$ or so
- 12 much thereof as may be necessary for fiscal year 2025-2026 and
- 13 the sum of \$ or so much thereof as may be necessary
- 14 for fiscal year 2026-2027 for the reimbursement to the state
- 15 general fund of debt service on reimbursable general obligation
- 16 bonds, including ongoing expenses related to the issuance of the
- 17 bonds, for the Waiahole water system.
- 18 The sums appropriated shall be expended by the agribusiness
- 19 development corporation for the purposes of this Act.
- 20 SECTION 4. This Act shall take effect on July 1, 3000.
