A BILL FOR AN ACT

RELATING TO HOMELESSNESS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that according to the 2 2024 Homeless Counts by State, Hawaii is ranked fifth in the 3 nation for highest rates per capita of homelessness. The 2024 4 Oahu Point in Time Count reported that among homeless persons, 5 sheltered and unsheltered: forty per cent were chronically 6 homeless; twenty-six per cent self-reported substance abuse 7 problems; thirty-three per cent self-reported a mental illness; 8 fifty-five per cent reported one or more disabling conditions; 9 and thirty-six per cent reported a physical, developmental, or 10 other disability. The 2024 Bridging the Gap Point in Time Count 11 reported that of the 1,276 unsheltered individuals, forty per 12 cent reported a mental illness and thirty-four per cent reported 13 having a substance use disorder.

14 The legislature further finds that homeless individuals
15 suffering from behavioral health conditions are often high users
16 of hospital emergency departments, which costs the State's
17 health system millions of dollars each year for emergency

1 ambulance transportation and emergency mental health 2 evaluations. These frequent utilizers of emergency and homeless 3 services often present with co-occurring illnesses; they need 4 specialized care that requires clinical expertise to evaluate 5 their physical and mental impairments and assist in overcoming 6 barriers to accessing proper medical treatment and resources to 7 meet basic needs like food, hygiene, safety, and transportation. 8 The legislature also finds that the 'Imi Ola Piha homeless 9 triage and treatment center, piloted by The Institute for Human 10 Services through a grant-in-aid since June 5, 2023, has been 11 successful in moving homeless individuals off the street by 12 facilitating the first step of detoxing from addiction to 13 alcohol and other drugs, including opioids and methamphetamine. 14. During its initial seventeen months of operation, through 15 collaboration with police, outreach specialists, and other 16 community providers, the eight-bed service site has triaged well over four hundred referrals for treatment. Of the three hundred 17 18 sixty-five clients taken in, the triage and treatment center has 19 successfully detoxed three hundred fifty-four clients with 20 medically assisted withdrawal management and stabilized the 21 mental illnesses of one hundred thirty-four clients. and treatment center has also transitioned individuals who were
 detoxed and stabilized into appropriate treatment and housing
 situations, providing services for individuals residing in every
 county throughout the State.

5 The lack of triage and treatment services has been a major 6 gap in the State's system of behavioral health care for homeless 7 persons and others with mental illness or substance use disorders. When a person is ready and seeking treatment, they 8 9 should be able to access it immediately. This is particularly true for those who suffer from substance use disorders for whom 10 11 the window of contemplation about the benefits of treatment is 12 often brief and fleeting. The safety and constant supervision 13 available in a triage and treatment center is in stark contrast 14 to the chaos and vulnerability individuals experience on the 15 street. Furthermore, trauma-informed services based in the 16 community foster active client participation and support, which 17 are critical to effective engagement in treatment and patient 18 retention and success for the individual upon exiting the 19 treatment center.

 SECTION 5. This Act shall take effect on July 1, 3000.
