# A BILL FOR AN ACT

RELATING TO PARKINSON'S DISEASE RESEARCH.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Parkinson's disease
- 2 is a chronic neurodegenerative disease that gradually worsens
- 3 over time. Parkinson's disease occurs when the brain cells that
- 4 produce dopamine, a neurotransmitter that coordinates movement,
- 5 become slow, stop working correctly, or die. There is no known
- 6 treatment to stop or reverse the progression of Parkinson's
- 7 disease, nor is there a cure. The legislature also finds that
- 8 there are approximately one million people in the United States
- 9 living with Parkinson's disease, which is estimated to rise to
- 10 1,600,000 by 2037. At least one hundred ten thousand veterans
- 11 in the United States, and between four and seven thousand people
- 12 in the State, live with Parkinson's disease.
- 13 The legislature further finds that the estimated annual
- 14 national economic burden to society from Parkinson's disease is
- 15 \$52,000,000,000 each year in medical and non-medical expenses.
- 16 That number is expected to exceed \$79,000,000,000 by 2037. The
- 17 importance of collecting critical research data is the first

- 1 step to better understand who develops Parkinson's disease and
- 2 why.
- 3 Accordingly, the purpose of this Act is to expand the
- 4 State's understanding of Parkinson's disease to ultimately
- 5 improve the lives of those affected, determine incidence and
- 6 prevalence of Parkinson's disease more accurately by state, and
- 7 improve understanding of the link between Parkinson's disease
- 8 and military service, since a larger portion of the veteran
- 9 community has Parkinson's disease as compared to the general
- 10 population, by establishing a Parkinson's disease research
- 11 collection database within the department of health.
- 12 SECTION 2. Chapter 321, Hawaii Revised Statutes, is
- 13 amended by adding a new part to be appropriately designated and
- 14 to read as follows:
- 15 "PART . PARKINSON'S DISEASE RESEARCH
- 16 §321-A. Definitions. As used in this part:
- "Department" means the department of health.
- "Director" means the director of health.
- 19 "Parkinsonisms" means related conditions that cause a
- 20 combination of the movement abnormalities seen in Parkinson's
- 21 disease, such as tremor at rest, slow movement, muscle rigidity,

- 1 impaired speech or muscle stiffness that often overlap with and
- 2 can evolve from what appears to be Parkinson's disease, such as
- 3 multiple system atrophy, dementia with Lewy bodies, corticobasal
- 4 degeneration, and progressive supranuclear palsy.
- 5 "Parkinson's database" means the Parkinson's disease
- 6 research collection database established pursuant to section
- 7 321-B.
- 8 "Parkinson's disease" means a chronic and progressive
- 9 neurologic disorder resulting from deficiency of the
- 10 neurotransmitter dopamine as the consequence of specific
- 11 degenerative changes in the area of the brain called the basal
- 12 ganglia characterized by tremor at rest, slow movements, muscle
- 13 rigidity, stooped posture, and unsteady or shuffling gait.
- 14 "Parkinson's disease research collection database advisory
- 15 committee" or "advisory committee" means the Parkinson's disease
- 16 research collection database advisory committee established
- 17 pursuant to section 321-C.
- 18 §321-B Parkinson's disease research collection database.
- 19 (a) There is established the Parkinson's disease research
- 20 collection database to be administered by the department. The
- 21 Parkinson's database shall house a collection of data on the

- 1 incidence of Parkinson's disease in the State and other
- 2 epidemiological data as defined in this section. The
- 3 Parkinson's database, system of collection, and dissemination of
- 4 information shall be under the direction of the director.
- 5 (b) All patients diagnosed with Parkinson's disease or
- 6 related Parkinsonisms shall be provided oral and written notice
- 7 regarding the collection of information and patient data on
- 8 Parkinson's disease and the right to opt-out of data collection.
- 9 Patient participation in the Parkinson's database shall be
- 10 voluntary; provided that patients who do not wish to participate
- 11 in the collection of data for purposes of the database shall
- 12 affirmatively opt-out in writing.
- (c) The department shall:
- 14 (1) Establish a system for collecting and disseminating
- information determining the incidence and prevalence
- of Parkinson's disease and related Parkinsonisms, as
- 17 advised by the advisory committee;
- 18 (2) Require that Parkinson's disease and related
- 19 Parkinsonisms diagnoses and treatment be reported to
- the department; provided that, for any patient who
- does not participate in the Parkinson's database, the

1		mere incidence of a patient with Parkinson's disease
2		shall be the sole required information;
3	(3)	Provide notification of the mandatory reporting of
4		Parkinson's disease and Parkinsonism on its website,
5		to associations representing physicians and hospitals,
6		and directly to the Hawaii medical board at least
7		ninety days before requiring the information to be
8		reported;
9	(4)	Maintain an accurate record of all persons who are
10		given access to confidential information from the
11		Parkinson's database, which shall include:
12		(A) The name of the person authorizing access;
13		(B) The name, title, address, and organizational
14		affiliation of persons given access, and dates of
15		access; and
16		(C) The specific purpose for which information is to
17		be used; and
18	(5)	Promulgate a coding system that removes any
19		identifying information about the patient.
20	(d)	The department may:

1	(1)	Enter into contracts, grants, or other agreements
2		necessary for the administration of the Parkinson's
3		database;
4	(2)	Create, review, and revise a list of data points
5		required as part of mandated Parkinson's disease
6		reporting under this section; provided that the list
7		shall include necessary triggering diagnostic
8		conditions, consistent with the latest international
9		statistical classification of diseases and related
10		health problems, and resulting case data including
11		diagnosis, treatment, and survival;
12	(3)	Implement and administer this part through a bulletin
13		or similar instruction to providers, which shall be
14		exempt from the rulemaking process pursuant to chapter
15		91;
16	(4)	Enter into data sharing contracts with data reporting
17		entities and their associated electronic medical
18		record systems vendors to securely and confidentially
19		receive information related to Parkinson's disease

	(3)	Enter theo agreements to furnish data corrected in the
2		Parkinson's database to other states' Parkinson's
3		disease registries, federal Parkinson's disease
4		control agencies, local health officers, or health
5		researchers for the study of Parkinson's disease;
6		provided that, before confidential information is
7		disclosed, the requesting entity shall agree in
8		writing to maintain the confidentiality of the
9		information, and in the case of health researchers,
10		shall:
11		(A) Obtain approval of their governing committee or
12		institutional review board for the protection of
13		human subjects established in accordance with
14		title 45 Code of Federal Regulations section
15		46.101 et seq.; and
16		(B) Provide documentation to the department that
17		demonstrates to the department's satisfaction
18		that the entity has established the procedures
19		and ability to maintain the confidentiality of

the information.

1 (e) Any hospital, facility, physician, surgeon, physician 2 assistant, advanced practice registered nurse, or other health care provider deemed necessary by the department, diagnosing or 3 providing primary clinical treatment for Parkinson's disease or 4 5 Parkinsonism patients shall report each case of Parkinson's 6 disease and Parkinsonisms to the department in a format 7 prescribed by the department. 8 This section shall not preempt the authority of (f) 9 facilities or individuals providing diagnostic or treatment 10 services to patients with Parkinson's disease to maintain its 11 own facility-based Parkinson's database. 12 §321-C Parkinson's disease research collection database 13 advisory committee. (a) The department shall establish a 14 Parkinson's disease research collection database advisory 15 committee, which shall consist of an odd number of members, not 16 less than nine, who shall be appointed by the director and include at least one of each of the following: 17 18 (1)General neurologist; 19 (2) Movement disorder specialist;

Primary care physician;

(4) Physician informaticist;

- 1 (5) Patient living with Parkinson's disease;
- 2 (6) Public health staff;
- 3 (7) Population health researcher familiar with registries;
- 4 (8) Parkinson's disease researcher; and
- (9) Any other member the department deems appropriate andnecessary.
- 7 (b) Each member shall serve for a term of three years;
- 8 provided that the director shall initially appoint three or more
- 9 members to serve for one year; three members to serve for two
- 10 years; and three members to serve for three years. No member
- 11 shall serve for more than two consecutive three-year terms.
- 12 (c) Vacancies occurring before the expiration of a
- 13 member's term shall be filled by election by the advisory
- 14 committee. Individuals elected to fill a vacancy shall serve
- 15 only for the remainder of the unexpired term.
- 16 (d) The advisory committee shall appoint from its members
- 17 a chairperson, vice chairperson, secretary, treasurer, and other
- 18 officers that the advisory committee deems necessary or
- 19 desirable to carry out its functions.
- 20 (e) Members of the advisory committee shall serve without
- 21 compensation, but may be reimbursed for the necessary expenses,

- ${f 1}$  including travel expenses, incurred in the performance of their
- 2 duties.
- 3 (f) The advisory committee shall:
- 4 (1) Assist in the development and implementation of the 5 Parkinson's disease research collection database;
- 6 (2) Determine the types of data that shall be collected;
- 7 and
- **8** (3) Advise the department.
- 9 §321-D Confidentiality of information. (a) Except as
  10 otherwise provided in this section, all information collected
  11 pursuant to this part shall be confidential.
- 12 (b) Notwithstanding any other law to the contrary, a
  13 disclosure authorized by this part shall include only the
  14 information necessary for the stated purpose of the requested
  15 disclosure, used for the approved purpose, and shall not be
- 16 further disclosed. The record of access shall be open to public
- 17 inspection during normal operating hours of the department.
- (c) Any person, agency, or entity who complies with this
- 19 part shall not be held civilly or criminally liable for
- 20 providing the information authorized by this part.

- 1 (d) Any information disclosed pursuant to this part shall
- 2 not be considered a waiver of any privilege or a violation of a
- 3 confidential relationship.
- 4 (e) Notwithstanding any other law to the contrary,
- 5 confidential information shall not be available for subpoena,
- 6 disclosed, discoverable, or compelled to be produced in any
- 7 civil, criminal, administrative, or other proceeding.
- 8 Confidential information shall not be deemed admissible as
- 9 evidence in any civil, criminal, administrative, or other
- 10 tribunal or court for any reason.
- 11 (f) This section shall not prohibit the department from
- 12 publishing reports and statistical compilations that do not
- 13 identify individual cases or sources of information.
- 14 (g) Notwithstanding the restrictions in this section, the
- 15 individual to whom the information pertains shall have access to
- 16 their own information.
- 17 §321-E Database webpage; annual reports. (a) No later
- 18 than January 1, 2026, the department shall create and maintain a
- 19 Hawaii Parkinson's disease research collection database webpage,
- 20 where the public may obtain information related to the registry
- 21 established by this part, a yearly program summary, and any

- 1 other relevant or helpful information related to the registry as
- 2 deemed necessary by the Parkinson's disease research collection
- 3 database advisory committee.
- 4 (b) No later than January 1, 2026, and every year
- 5 thereafter, the department shall submit a report to the
- 6 legislature that provides a yearly summary update on the
- 7 incidents and prevalence of Parkinson's disease in the State by
- 8 county, the number of records that have been included and
- 9 reported in the registry, and the demographic information of
- 10 patients by age, gender, and race. A copy of the report shall
- 11 be made available and posted on the department's webpage
- 12 established pursuant to subsection (a)."
- 13 SECTION 3. In codifying the new sections added by section
- 14 2 of this Act, the revisor of statutes shall substitute
- 15 appropriate section numbers for the letters used in designating
- 16 the new sections in this Act.
- 17 SECTION 4. This Act shall take effect on July 1, 3000.

### Description:

Establishes the Parkinson's Disease Research Collection Database to be administered by the Department of Health, to house a collection of data on the incidence of Parkinson's disease in the State. Requires the Department to create a Parkinson's disease research collection database webpage by 1/1/2026, and submit annual reports to the Legislature. Effective 7/1/3000. (HD1)
