MAKING APPROPRIATIONS FOR CLAIMS AGAINST THE STATE, ITS

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 PART I

2 SECTION 1. The following sums or so much thereof as may be
3 necessary for fiscal year 2024-2025 are appropriated out of the
4 general revenues of the State of Hawaii to the department of the
5 attorney general for the purpose of satisfying claims for
6 legislative relief as to the following named persons, firms,
7 corporations, and entities, for claims against the State or its
8 officers or employees, for the overpayment of taxes, or for
9 refunds, reimbursements, payments of judgments or settlements,
10 or other liabilities, in the amounts set forth opposite their

PART IV



1 SECTION 4. In accordance with section 9 of article VII of
2 the Constitution of the State of Hawaii and sections 37-91 and
3 37-93, Hawaii Revised Statutes, the legislature has determined
4 that the state general fund expenditure ceiling for fiscal year
5 2024-2025 has already been exceeded by \$8,551,795, or one per
6 cent. In addition, the appropriations contained in this Act
7 will cause the state general fund expenditure ceiling for fiscal
8 year 2024-2025 to be further exceeded by \$,
9 or per cent. The reasons for exceeding the general fund
10 expenditure ceiling are that the appropriation made in this Act
11 is necessary to serve the public interest and to meet the needs
12 addressed by this Act.

13 PART V

14 SECTION 5. The sums hereinabove may be paid to the
15 respective persons, firms, corporations, or entities for the
16 satisfaction or settlement of the respectively identified cases,
17 and in several amounts hereinabove set forth or in lesser
18 amounts deemed appropriate, upon checks issued by the
19 comptroller; provided that departments shall obtain the approval
20 of the attorney general before payment of any claim may be made.



1 SECTION 6. Notwithstanding the sums hereinabove stated as
2 interest upon judgments against the State, payment of interest
3 shall be limited to the period from the date of the judgment, if
4 applicable, to thirty days after the effective date of this Act,
5 as provided in section 662-8, Hawaii Revised Statutes, for those
6 cases to which the statute applies.

7 SECTION 7. All unexpended and unencumbered balances of the
8 appropriations made in this Act as of the close of business on
9 June 30, 2026, shall lapse.

10 SECTION 8. If any provision of this Act, or the
11 application thereof to any person or circumstance, is held
12 invalid, the invalidity does not affect other provisions or
13 applications of the Act that can be given effect without the
14 invalid provision or application, and to this end the provisions
15 of this Act are severable.

16 SECTION 9. This Act shall take effect on July 1, 3000.
