

HOUSE CONCURRENT RESOLUTION

REQUESTING THE OFFICE OF PLANNING AND SUSTAINABLE DEVELOPMENT TO CONVENE A WORKING GROUP TO EVALUATE THE ESTABLISHMENT AND ADMINISTRATIVE PLACEMENT OF AN OFFICE OF RESILIENCE AND RECOVERY.

WHEREAS, the Maui wildfires led to over one hundred 1 2 fatalities and nearly \$12,000,000,000 in damages; and 3 WHEREAS, in the aftermath of the Maui wildfires, the Hawai'i 4 5 Climate Advisory Team was established as an advisory group to propose policies that improve the State's ability to effectively 6 respond to disasters; and 7 8 WHEREAS, the Climate Advisory Team recommended in its 9 January 2025 Policy Recommendations on Climate Disaster 10 Resilience, Recovery and Funding that a permanent Hawaii 11 Resilience Office be established to provide leadership and 12 coordination to improve the State's resilience and preparedness 13 for disasters; and 14 15 16 WHEREAS, the Climate Advisory Team did not make a specific recommendation regarding the placement of the Hawaii Resilience 17 Office; and 18 19 WHEREAS, the Climate Advisory Team acknowledged that while 20 the temporary Hawaii Office of Recovery and Resiliency and 21 Hawaii Emergency Management Agency have elements of resilience 22 in their missions, the responsibility for resilience planning 23 24 and implementation should reside clearly in one department; now, therefore, 25 26 BE IT RESOLVED by the House of Representatives of the 27 Thirty-third Legislature of the State of Hawaii, Regular Session 28 29 of 2025, the Senate concurring, that the Office of Planning and
