HOUSE CONCURRENT RESOLUTION

URGING THE UNIVERSITY OF HAWAII TO IMPLEMENT A HOMELESS STUDENT STABILITY AND HOUSING RESOURCE PROGRAM TO ADDRESS THE ISSUE OF HOUSING INSTABILITY.

WHEREAS, post-secondary students should be able to access 1 resources that help them meet their basic needs; and 2 3 WHEREAS, basic needs are defined as access to stable 4 5 housing, food, and healthcare services; and 6 7 WHEREAS, a poll conducted by The Hope Center for College, Community, and Justice for the University of Hawaii Basic Needs 8 Committee in Fall 2020 found that fifty-eight percent of 9 10 students enrolled at one or more of the ten University of Hawaii post-secondary institutions faced at least one form of basic 11 12 needs insecurity (BNI); and 13 WHEREAS, of the three types of BNI studied, forty-four 14 percent of students experienced housing insecurity, fourteen 15 percent experienced homelessness, and thirty-nine percent 16 17 experienced food insecurity; and 18 WHEREAS, the same study found that only fifteen percent of 19 students experiencing BNI received emergency aid; and 20 21 22 WHEREAS, of the eighty-five percent of students that did not receive aid, seventy-eight percent did not think they would 23 be eligible and fifty-eight percent of students polled did not 24 know the program existed or how to apply; and 25 26 WHEREAS, student mental health stability and support is a 27 priority component of healthcare services impacting a 28 significant percent of students; and 29 30

1 WHEREAS, the recommended standard ratio of mental health practitioners to students is one mental health practitioner to 2 one thousand to one thousand five hundred students; and 3 4 WHEREAS, the University of Hawaii at Manoa currently staffs 5 a total of 0.5 full-time equivalent psychiatrists and 4.5 full-6 7 time equivalent psychologists with a student population of 20,048, for a ratio of one staff position to four thousand ten 8 students; and 9 10 11 WHEREAS, the conditions contributing to basic needs insecurity have primarily worsened since the 2020 Hope Center 12 study was conducted; and 13 14 15 WHEREAS, the University of Hawaii Basic Needs Committee is 16 currently conducting a study to assess the rates of BNI amongst the current student body; now, therefore, 17 18 19 BE IT RESOLVED by the House of Representatives of the Thirty-third Legislature of the State of Hawaii, Regular Session 20 of 2025, the Senate concurring, that the University of Hawaii is 21 urged to implement a homeless student stability and housing 22 resource program to address the issue of housing instability; 23 24 and 25 BE IT FURTHER RESOLVED that the University of Hawaii is 26 requested to utilize the results of the 2025 survey being 27 28 conducted by the University of Hawaii Basic Needs Committee to 29 develop a plan to address basic needs insecurity within the student population, strengthen mental health services, and 30 increase awareness of, and access to, resources and support; and 31 32 33 BE IT FURTHER RESOLVED that certified copies of this Concurrent Resolution be transmitted to the Chairperson of the 34 Board of Regents of the University of Hawaii and President of 35 the University of Hawaii. 36 37 38 39 OFFERED BY:
