HOUSE RESOLUTION

ESTABLISHING THE TASK FORCE FOR SPEED (SIMPLIFYING PERMITTING FOR ENHANCED ECONOMIC DEVELOPMENT) TO IDENTIFY ACTIONS NEEDED TO EXPEDITE, FACILITATE, AND COORDINATE STATE AND INTERGOVERNMENTAL PERMIT PROCESSES.

1 WHEREAS, the permitting process can be subject to lengthy waiting periods, leading to delays in housing, industrial, and 2 3 commercial projects and stifling economic development in the State; and 4 5 6 WHEREAS, bringing together representatives from the various 7 agencies responsible for permitting can greatly enhance understanding of issues present in the permitting process and 8 help determine changes needed to expedite the process; now, 9 therefore, 10 11 BE IT RESOLVED by the House of Representatives of the 12 Thirty-third Legislature of the State of Hawaii, Regular Session 13 of 2025, that there is established the Task Force for SPEED 14 (Simplifying Permitting for Enhanced Economic Development) to 15 identify actions needed to expedite, facilitate, and coordinate 16 state and intergovernmental permit processes; and 17 18 19 BE IT FURTHER RESOLVED that the task force is requested to consist of the following individuals: 20 21 22 (1) One member of the House of Representatives, to be appointed by the Speaker of the House of 23 Representatives, who shall serve as the Chair of the 24 task force; 25 26 (2) One member of the Senate, to be appointed by the 27 President of the Senate; 28 29 (3) A representative from the Office of the Governor; 30 31
