HOUSE RESOLUTION

ESTABLISHING THE TASK FORCE FOR SPEED (SIMPLIFYING PERMITTING FOR ENHANCED ECONOMIC DEVELOPMENT) TO IDENTIFY ACTIONS NEEDED TO EXPEDITE, FACILITATE, AND COORDINATE STATE AND INTERGOVERNMENTAL PERMIT PROCESSES.

WHEREAS, the permitting process can be subject to lengthy waiting periods, leading to delays in housing, industrial, and commercial projects and stifling economic development in the State; and

WHEREAS, bringing together representatives from the various agencies responsible for permitting can greatly enhance understanding of issues present in the permitting process and help determine changes needed to expedite the process; now, therefore,

BE IT RESOLVED by the House of Representatives of the Thirty-third Legislature of the State of Hawaii, Regular Session of 2025, that there is established the Task Force for SPEED (Simplifying Permitting for Enhanced Economic Development) to identify actions needed to expedite, facilitate, and coordinate state and intergovernmental permit processes; and

BE IT FURTHER RESOLVED that the task force is requested to consist of the following individuals:

- One member of the House of Representatives, to be (1)appointed by the Speaker of the House of Representatives, who shall serve as the Chair of the task force;
- (2) A representative from the Office of the Governor;
- (3) A representative from the Department of Business, Economic Development, and Tourism;


BE IT FURTHER RESOLVED that the task force is requested to hold its first meeting no later than October 1, 2025; and
