A BILL FOR AN ACT

RELATING TO EARLY LEARNING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 302L, Hawaii Revised Statutes, is 2 amended by adding a new section to be appropriately designated
- 3 and to read as follows:
- 4 "\$302L- Imagination library of Hawaii program;
- 5 established. (a) The office shall establish an imagination
- 6 library of Hawaii program to provide one free book each month to
- 7 eligible children.
- 8 (b) The office shall contract with a nonprofit
- 9 organization to implement the program established pursuant to
- 10 this section. In implementing the imagination library of Hawaii
- 11 program, the nonprofit organization shall:
- 12 (1) Provide an amount of at least fifty per cent of the
- 13 funds required to carry out the program;
- 14 (2) Promote the statewide development of local
- 15 book-gifting programs;
- (3) Provide outreach to local communities about developing 16
- 17 local book-gifting programs in those communities;
