### A BILL FOR AN ACT

RELATING TO PUBLIC HOUSING.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 356D, Hawaii Revised Statutes, is
- 2 amended by adding a new section to part I to be appropriately
- 3 designated and to read as follows:
- 4 "S356D- Pet animals. (a) The authority shall allow any
- 5 resident of a public housing project or state low-income housing
- 6 project to keep one or more pet animals in the resident's unit,
- 7 subject to applicable state laws, county ordinances, and any
- 8 reasonable conditions.
- 9 (b) The authority may charge a refundable deposit for each
- 10 pet animal but shall not impose a monthly pet fee or pet rent.
- 11 (c) Nothing in this section shall prevent the authority
- 12 from immediately acting to remove a vicious animal to protect
- 13 persons or property.
- 14 (d) For purposes of this section:
- "Pet animal" has the same meaning as defined in section
- **16** 711–1100.
- "Reasonable conditions" include:

19	SECTION 3. This Act does not affect rights and duties that		
20	matured,	penalties that were incurred, and proceedings that	t were
21	begun bef	fore its effective date.

### Report Title:

HPHA; Pet Animals; Allowed; Appropriations

#### Description:

Requires the Hawaii Public Housing Authority to allow any resident of a public housing project or state low-income housing project to keep one or more pet animals in the resident's unit, subject to applicable state laws, county ordinances, and any reasonable conditions. Provides that HPHA may charge a refundable deposit for each pet animal but shall not impose a monthly pet fee or pet rent. Allows HPHA to remove a vicious animal to protect persons or property. Establishes positions. Appropriates funds.
