### A BILL FOR AN ACT

RELATING TO DOGS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. In recognition of the bond between humans and
- 2 animals and the status of pets as family members, many local
- 3 businesses are implementing pet-friendly policies to better
- 4 serve the needs of their customers.
- 5 The legislature finds that restauranteurs, however, are at
- 6 a disadvantage, as the State's administrative rules prohibit the
- 7 presence of non-service animals in restaurants. Some pet owners
- 8 attempt to circumvent these rules by misrepresenting their pets
- 9 as service animals, in violation of state law.
- 10 The legislature also finds that allowing restaurants the
- 11 option to welcome dogs onto their premises provides restaurants
- 12 freedom to better serve their customers, dog-owning patrons more
- 13 dining options to consider visiting with their dog, and
- 14 businesses an opportunity to broaden their customer base and
- 15 increase revenues.
- 16 The legislature further finds that reasonable safeguards
- 17 can prevent risks to public health that might otherwise result



- ${f 1}$  from adopting such a policy. A study published in 2013 in the
- 2 Journal of Environmental Health found no reported incidents
- 3 associated with allowing pets in restaurants and recommended
- 4 following the normal safety, sanitation, and hygiene practices
- 5 to minimize any threat to human health. Several states have
- 6 passed laws allowing restauranteurs to adopt dog-friendly
- 7 policies to better serve their customers and in recognition of
- 8 the growing bond between pets and their owners.
- **9** The purpose of this Act is to authorize restaurants to
- 10 allow dogs onto their premises under certain conditions.
- 11 SECTION 2. Chapter 321, Hawaii Revised Statutes, is
- 12 amended by adding a new section to be appropriately designated
- 13 and to read as follows:
- 14 "§321- Dogs allowed on restaurant premises. (a) At the
- 15 discretion of the owner or manager of a restaurant, a restaurant
- 16 patron may bring a dog onto the restaurant premises under the
- 17 following conditions:
- 18 (1) The dog shall be under the control of the patron at
- 19 all times and in a carrier or on a leash that is held
- 20 by the patron or tied to the patron's table;

1	(2)	The dog shall remain within the patron's seating area
2		and on the floor;
3	(3)	The dog shall remain in a location or area on the
4		restaurant premises designated pursuant to subsection
5		<u>(b);</u>
6	(4)	The dog shall not obstruct pathways, interfere with
7		the activities of the restaurant's employees, or enter
8		the food preparation area;
9	(5)	The dog shall not disturb or interact with other
10		patrons or dogs, except by invitation;
11	(6)	The dog shall be housebroken; provided that if the dog
12		relieves itself on the restaurant premises, the patron
13		shall be responsible for thoroughly cleaning up after
14		the dog and any affected areas;
15	<u>(7)</u>	The patron shall not leave the dog unattended at any
16		time; and
17	<u>(8)</u>	The patron and the dog shall abide by any other
18		conditions that the owner or manager of the restaurant
19		requires.
20	(b)	A restaurant that allows dogs in to enter and remain
21	on the re	staurant premises shall:



1	(1)	Determine and designate the location or area and
2		amount of space on the restaurant premises where
3		patrons may be accompanied by dogs;
4	(2)	Prohibit food-service employees from having direct
5		contact with a dog while on duty;
6	<u>(3)</u>	Require that any food-service employee who comes into
7		contact with a dog wash their hands as required by
8		law; and
9	(4)	Post at each entrance a sign displaying the message
10		"Dogs are allowed in this restaurant", and shall also
11		post adjacent to that sign the list of conditions in
12		subsection (a), including a clear description of any
13		additional conditions imposed by the owner or manager
14		of the restaurant.
15	<u>(c)</u>	Pursuant to title 28 Code of Federal Regulations
16	section 3	5.136, or if any of the conditions in subsection (a)
17	are not me	et, the owner or manager of the restaurant may require
18	the patro	n to remove the dog from the restaurant premises.
19	(d)	The restaurant patron who brings a dog onto the
20	restauran	t premises and the dog's owner, if the owner is not the

1	patron, shall be liable for all property damages and personal
2	injury that the dog causes while on the restaurant premises.
3	(e) For the purposes of this section, "restaurant" means
4	any place where food is served or provided to the public at a
5	charge, including outdoor seating areas, regardless of whether
6	the food is consumed on or off the premises.
7	(f) If any provision of this section conflicts with
8	federal law governing service animals, federal law shall
9	prevail.
10	(g) Any patron of a restaurant that misrepresents a dog as
11	a service animal to circumvent the requirements of this section
12	shall be subject to fines and penalties pursuant to 347-2.6."
13	SECTION 3. New statutory material is underscored.
14	SECTION 4. This Act shall take effect on July 1, 2025.
