A BILL FOR AN ACT

RELATING TO PEDESTRIANS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that current statutes 2 relating to pedestrians are needlessly restrictive. Fines for 3 pedestrians can have a disproportionate impact on people who do 4 not drive and who primarily rely upon walking as a means of transportation. The legislature notes that, in many situations, 5 6 the perception and judgment of pedestrians can be more effective 7 in mitigating injuries than traffic lights or street markings. 8 The legislature additionally finds that pedestrians should be 9 trusted to cross the street when the absence of oncoming traffic 10 makes it reasonably safe to cross, even if the decision to cross 11 the street requires pedestrians to act contrary to existing 12 traffic rules; provided that pedestrians use reasonable care in 13 making such crossings.

14 The legislature further finds that there are numerous 15 benefits to walking, which can include greater physical 16 longevity, lower personal expenses for transportation, and a 17 decrease in the carbon dioxide entering the atmosphere.

1 Further, California, with the support of over ninety pedestrian 2 advocacy groups, passed the Freedom to Walk Act in 2022, which substantially relaxed enforcement of pedestrian street-crossing 3 violations and makes California's streets more walkable. 4 Accordingly, the purpose of this Act is to provide 5 6 pedestrians with greater freedom by: 7 Allowing them to act contrary to the statewide traffic (1) 8 code when a reasonably careful pedestrian would 9 consider it safe to do so if the pedestrian is more 10 than two hundred feet from a crosswalk; and 11 (2) Requiring any driver of a vehicle to yield to a 12 pedestrian who clearly indicates their intention to 13 cross the roadway at a crosswalk. 14 SECTION 2. Chapter 291C, Hawaii Revised Statutes, is 15 amended by adding a new section to part VII to be appropriately 16 designated and to read as follows: 17 "§291C- Freedom to walk; absence of an immediate danger. 18 (a) Notwithstanding any law to the contrary, a pedestrian shall 19 not be stopped by a law enforcement officer, fined, or subjected 20 to any other penalty, for acting contrary to this chapter, 21 unless a reasonably careful pedestrian would determine that

Report Title: Pedestrians; Safety; Street Crossing

Description:

Authorizes pedestrians to act contrary to the statewide traffic code when a reasonably careful pedestrian would determine that there is no immediate danger of a collision with a moving vehicle if the pedestrian is more than 200 feet from a crosswalk. Requires a driver of a vehicle to yield to a pedestrian when the pedestrian clearly indicates their intention to cross a roadway within a crosswalk. Effective 7/1/2050. (SD1)
