A BILL FOR AN ACT

RELATING TO PORT INFRASTRUCTURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that maintenance dredging 2 is critical to the upkeep of small boat harbors, channels, 3 ramps, and other port infrastructure in the State. The legislature further finds that the current process of waiting 4 5 until dredging is imminent to appropriate funds and only then 6 initiating the permitting process creates a haphazard system for the allocation of money and the issuance of permits. This 7 disorganized process sometimes contributes to worsened 8 9 conditions at these facilities when increased amounts of marine sediment and foreign debris accumulate, sometimes up to a height 10 that can damage the hulls of ships if not cleared immediately. 11 12 These unsafe conditions can potentially cause a shutdown of the affected sites, which are important for recreation and 13 subsistence fishing and other use by the general public. 14

15 The purpose of this Act is to appropriate funds to the 16 department of land and natural resources to conduct maintenance

dredging at certain state small boat harbors, boat launch ramp 1 2 facilities, and other state boating facilities and waterways. 3 SECTION 2. There is appropriated out of the general revenues of the State of Hawaii the sum of \$ 4 or so 5 much thereof as may be necessary for fiscal year 2025-2026 and 6 the same sum or so much thereof as may be necessary for fiscal 7 year 2026-2027 for the purpose of conducting maintenance 8 dredging at state small boat harbors, boat launch ramp 9 facilities, and other state boating facilities and waterways, 10 including design, permitting, and dredging work, as identified 11 by the department of land and natural resources. 12 The sums appropriated shall be expended by the department of land and natural resources for the purposes of this Act. 13 14 SECTION 3. Beginning with fiscal biennium 2027-2029 and 15 each fiscal year thereafter, the department of land and natural 16 resources shall include in its annual budget request line-item funding for maintenance dredging at state boating facilities. 17 18 SECTION 4. This Act shall take effect on July 1, 2050.
