A BILL FOR AN ACT

RELATING TO TRANSPORTATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that noise pollution is a
- 2 serious problem affecting mental health and quality of life,
- 3 particularly in urban areas. Internal combustion engine mopeds
- 4 are significant contributors to noise pollution, often having
- 5 higher noise levels than motorcycles with larger displacement
- 6 and robust exhaust baffles.
- 7 The legislature further finds that electric mopeds are much
- 8 cheaper to operate and maintain than internal combustion engine
- 9 mopeds. Additionally, the broad deployment of charging
- 10 infrastructure is not an impediment to the adoption of electric
- 11 mopeds because electric moped batteries can be easily removed
- 12 and charged inside a residence or workplace.
- 13 The legislature also finds that numerous jurisdictions
- 14 including in Asia, Europe, and Africa have already required the
- 15 transition from internal combustion engine mopeds to electric
- mopeds.


