A BILL FOR AN ACT

RELATING TO AGRICULTURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the agricultural
- 2 industry in Hawaii has been significantly affected by climate
- 3 change, globalization, the influx of devastating invasive
- 4 species and diseases, market conditions, a lack of agricultural
- 5 workers, and various other factors. The legislature further
- 6 finds that the State must modernize and adapt its policies and
- 7 laws accordingly. The legislature also finds that unnecessary
- 8 or obsolete sections of the Hawaii Revised Statutes are impeding
- 9 the growth and success of agriculture in Hawaii and should be
- 10 carefully reviewed to ensure that this important part of the
- 11 islands' economy and way of life can survive and thrive into the
- 12 future.
- 13 Therefore, the purpose of this Act is to establish and
- 14 appropriate funds for a working group within the department of
- 15 agriculture to review and make recommendations on amending or
- 16 repealing unnecessary or obsolete laws pertaining to
- 17 agriculture.

7	(1)	The chairperson of the board of agriculture, or the

SECTION 2. (a) There is established within the department

11		president's designee, who shall be invited by the
12		chairperson of the working group.
13	(c)	The working group shall first review laws that
14	directly	impact agricultural viability and land use, including
15	but not 1	imited to:
16	(1)	Restrictions on leases of state agricultural land that
17		prohibit a residence on the property;
18	(2)	Restrictions on leases of state agricultural land that
19		prohibit the raising of poultry and swine on the
20		property;
21	(3)	Caps on agricultural operation loan rates;

- (4) Regulations governing agricultural workforce
 development and farm labor access;
- 3 (5) Water access and permitting; and
- 4 (6) Procurement policies that impact the use of locally5 grown food in state institutions.
- (d) The working group may identify and recommendadditional laws for future review in subsequent legislative
- 9 (e) Members of the working group who are employed by the
 10 State and serving in their official capacity on the working
 11 group shall serve without compensation. Other members of the
 12 working group who are not employed by the State shall receive
 13 compensation for their travel expenses.
- (f) No later than twenty days prior to the convening of
 the regular session of 2026, the working group shall submit a
 report of its findings and recommendations, including any
 proposed legislation, to the legislature regarding its review of
 unnecessary or obsolete laws pertaining to agriculture.
- 19 (g) The working group shall cease to exist on June 30,
 20 2026.

- 1 SECTION 3. There is appropriated out of the general
- 2 revenues of the State of Hawaii the sum of \$ or so
- 3 much thereof as may be necessary for fiscal year 2025-2026 for
- 4 the working group established pursuant to section 2 of this Act.
- 5 The sum appropriated shall be expended by the department of
- 6 agriculture for the purposes of this Act.
- 7 SECTION 4. This Act shall take effect on July 1, 3000.
