A BILL FOR AN ACT

RELATING TO TRANSPORTATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that chapter 279J, Hawaii
- 2 Revised Statutes, was enacted to establish statewide regulation
- 3 of transportation network companies to provide operational
- 4 consistency across the State and establish a permitting process
- 5 within the department of transportation.
- 6 The legislature further finds that transportation network
- 7 companies are required to adopt a policy of non-discrimination
- 8 on the basis of destination, race, color, ancestry, national
- 9 origin, religious belief or affiliation, sex, disability, age,
- 10 sexual orientation, or gender identity or expression with
- 11 respect to riders and potential riders and notify the
- 12 transportation network company drivers of the policy.
- 13 The legislature additionally finds that transportation
- 14 network company drivers are required to comply with all
- 15 applicable laws to accommodate service animals. Despite these
- 16 requirements, there have been many reports of passengers being

- 1 denied service by drivers due to being accompanied by a service
 2 animal.
 3 Accordingly, the purpose of this Act is to require the
- Accordingly, the purpose of this Act is to require the
- 4 civil rights commission to receive and investigate complaints
- 5 related to acts of discrimination committed by transportation
- 6 network company drivers and report its findings to the
- 7 department of transportation, which shall issue penalties to
- 8 transportation network companies.
- 9 SECTION 2. Chapter 279J, Hawaii Revised Statutes, is
- 10 amended by adding a new section to be appropriately designated
- 11 and to read as follows:
- 12 "\$279J- Complaint against unfair discrimination;
- 13 service animals; civil rights commission. The civil rights
- 14 commission shall receive complaints of unfair discriminatory
- 15 treatment of riders by transportation network company drivers in
- 16 violation of section 279-10(c) in accordance with the procedures
- established under chapter 368."
- 18 SECTION 3. Section 279J-10, Hawaii Revised Statutes, is
- 19 amended to read as follows:
- 20 "[f]§279J-10[f] Non-discrimination; accessibility. (a)
- 21 The transportation network company shall adopt a policy of

- 1 non-discrimination on the basis of destination, race, color,
- 2 ancestry, national origin, religious belief or affiliation, sex,
- 3 disability, age, sexual orientation, or gender identity or
- 4 expression with respect to riders and potential riders and shall
- 5 notify transportation network company drivers of the policy.
- 6 The transportation network company shall be accountable for and
- 7 ensure compliance with this section.
- **8** (b) In addition to any policy established pursuant to
- 9 subsection (a), transportation network company drivers shall
- 10 comply with all applicable laws regarding non-discrimination
- 11 against riders or potential riders on the basis of destination,
- 12 race, color, ancestry, national origin, religious belief or
- 13 affiliation, sex, disability, age, sexual orientation, or gender
- 14 identity or expression.
- 15 (c) Transportation network company drivers shall comply
- 16 with all applicable laws to accommodate service animals. For
- 17 purposes of this subsection, "service animal" has the same
- 18 meaning as defined in section 347-2.5.
- 19 (d) A transportation network company shall not impose
- 20 additional charges for providing services to persons with
- 21 physical disabilities.

1	<u>(e)</u>	Notwithstanding section 2/90-11, when the civil rights
2	commissio	n, pursuant to section 279J- , has found that a
3	transportation network company driver has violated subsection	
4	(c), the	civil rights commission shall report the results of its
5	investiga	tion of the complaint to the department, which shall
6	issue pen	alties to the transportation network company as
7	follows:	
8	(1)	For each violation, a fine of \$5,000;
9	(2)	For three violations within a period of twelve
10		consecutive months, a warning that the transportation
11		network company's permit is at risk of suspension; and
12	(3)	For ten or more cumulative violations, suspension of a
13		transportation network company's permit for a period
14		of no less than twelve consecutive months.
15	The department shall make the penalties established pursuant to	
16	this sect	ion publicly available on the department's website."
17	SECT	ION 4. This Act does not affect rights and duties that
18	matured,	penalties that were incurred, and proceedings that were
19	begun bef	ore its effective date.
