1	(b) The state breast milk bank may collect a reasonable			
2	fee from users of the breast milk bank for the operation of the			
3	state breast milk bank.			
4	§321-B State breast milk bank special fund. (a) There is			
5	established the state breast milk bank special fund to be			
6	administered by the department. The fund shall consist of:			
7	(1) Fees collected pursuant to section 321-A(b);			
8	(2) Federal funds granted by Congress or Executive Order			
9	for the purposes of the special fund;			
10	(3) Appropriations by the legislature; and			
11	(4) All accrued interest from the fund.			
12	(b) Moneys in the special fund shall be used for the			
13	purposes of operating and administering the state breast milk			
14	bank or contracting with a qualified entity, pursuant to chapter			
15	103F, to operate and administer the state breast milk bank.			
16	(c) Any moneys that accumulate in the special fund shall			
17	be retained in the fund unless determined by the legislature to

19	SECTION 2. There is appropriated out of the general

1 thereof as may be necessary for fiscal year 2025-2026 to be 2 deposited into the state breast milk special fund. 3 SECTION 3. There is appropriated out of the state breast 4 milk special fund the sum of \$ or so much thereof as 5 may be necessary for fiscal year 2025-2026, and the same sum or so much thereof as may be necessary for fiscal year 2026-2027 6 7 for the operation of state breast milk bank. 8 The sums appropriated shall be expended by the department 9 of health for the purposes of this Act. 10 SECTION 4. In codifying the new sections added by section 11 1 of this Act, the revisor of statutes shall substitute 12 appropriate section numbers for the letters used in designating 13 the new sections in this Act. 14 SECTION 5. New statutory material is underscored. 15 SECTION 6. This Act shall take effect on July 1, 2025. 16
