### A BILL FOR AN ACT

RELATING TO FIREWORKS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature recognizes the destruction and 2 devastation that the setting-off of unpermitted fireworks has had on the people of Hawai'i, including multiple deaths and 3 critical injuries of dozens more that occurred on New Year's 4 Eve, December 31, 2024. The legislature finds that hundreds of 5 6 thousands of residents have been traumatized in their homes, along with their pets, by excessive noise, smoke, and airborne 7 debris, often for multiple days during the month of December and 8 9 at all hours. Their personal safety and private property are also threatened. Hawai'i's emergency response personnel and 10 11 hospitals are equally burdened by reckless and illegal fireworks 12 activity.

13 The legislature further finds that many of Hawai'i's 14 residents do not support illegal fireworks being ignited in 15 their neighborhoods. The people in the State and their 16 communities deserve to live in peace and security, without the 17 public safety risk and disruptive impact of illegal fireworks.

1 The legislature also finds that, in an effort to address 2 the problem of illegal fireworks, the legislature passed Act 170, Session Laws of Hawaii 2010, which established the 3 illegal fireworks task force to develop strategies and make 4 5 recommendations to address the illegal importation and use of 6 fireworks in the State. Among other things, the task force recommended increasing random inspections for illegal fireworks 7 by expanding inspection authority and focusing cargo inspections 8 9 to make the inspections more manageable.

Subsequently, pursuant to Act 184, Session Laws of Hawaii 10 11 2019, the legislative reference bureau updated the findings and recommendations of the Report of the Illegal Fireworks Task 12 Force to the Legislature for the Regular Session of 2011. The 13 2019 legislative reference bureau report, Blast from the Past: 14 15 An Update to the Report of the Illegal Fireworks Task Force to the Legislature for the Regular Session of 2011, indicated that 16 17 the "majority of respondents to the [Legislative Reference] 18 Bureau's Survey appeared to agree that the issues and challenges 19 presented by the Task Force in its 2011 report remain relevant 20 today". In 2023, pursuant to Act 67, Session Laws of Hawaii 21 2023, an illegal fireworks task force was established within the

1 newly created department of law enforcement to, using the 2 findings from the 2019 report, develop "a comprehensive 3 strategic plan to stop the importation of illegal fireworks and 4 explosives into Hawaii; promote compliance with the state 5 fireworks control laws; and ensure the safety and security of 6 the airports, harbors, and other facilities and institutions in 7 the State against the discharge of illegal fireworks and 8 explosives".

9 The legislature understands this is a complex issue that 10 will require collaboration from many people and agencies. The 11 intent of this Act is not to attempt to change or diminish the 12 job duties of department of transportation employees who 13 currently have inspection responsibilities, nor is it attempting 14 to interfere with existing collective bargaining agreements. 15 The legislature finds it is important to safequard the health 16 and safety of those in Hawai'i. The use of illegal fireworks 17 often leads to serious, permanent bodily injury, death, and 18 causes stress and anxiety for those living with post-traumatic 19 stress disorder.

20 The purpose of this Act is to address the illegal 21 importation and use of fireworks in the State by:

1	(1)	Include the use of fireworks- or explosive-sniffing
2		dogs to inspect incoming shipping containers to the
3		greatest extent reasonable at a designated secure
4		site, and if logistically necessary, located away from
5		a commercial harbor;
6	(2)	Prioritize resources toward high-risk containers over
7		low-risk containers. For the purposes of this
8		paragraph, "low-risk container" means shipping
9		containers containing goods to be delivered to the
10		military, state or county agencies, and businesses
11		registered to do business in the State that are
12		determined to be in good standing by the department of
13		commerce and consumer affairs;
14	(3)	Inspect all shipping containers containing legal
15		fireworks using personnel who are able to distinguish
16		legal fireworks from illegal fireworks at a designated
17		secure site and, if logistically necessary, located
18		away from a commercial harbor; and
19	(4)	Balance safety concerns with commercial interests to
20		avoid increases in consumer costs.

1	(c) The department of law enforcement shall coordinate and
2	conduct the random inspection of shipping containers pursuant to
3	this section. The Hawaii national guard may be utilized to
4	assist in the random inspection of shipping containers.
5	(d) Any container identified by the department of law
6	enforcement as requiring additional inspection for possible
7	illegal fireworks shall be inspected by the appropriate
8	bargaining unit employees and shall not be performed by a
9	contractor or subcontractor.
10	(e) The department of law enforcement may request funding
11	from federal sources for homeland security and port security
12	measures and work with the United States military to secure
13	other funding sources for the purposes of the program.
14	(f) The department of law enforcement shall adopt rules in
15	accordance with chapter 91 for the purposes of this section."
16	SECTION 3. No later than forty days prior to the convening
17	of the regular sessions of 2026 and 2027, the department of law
18	enforcement shall submit to the legislature reports on the
19	implementation of the shipping container inspection program
20	established pursuant to this Act. The reports shall include
21	findings and recommendations, including costs expended to date,

1 the estimated cost of operating the program, and any proposed 2 legislation.

3 SECTION 4. There is appropriated out of the general 4 revenues of the State of Hawaii the sum of \$750,000 or so much 5 thereof as may be necessary for fiscal year 2025-2026 and the 6 same sum or so much thereof as may be necessary for fiscal year 7 2026-2027 for costs to establish and administer the shipping 8 container inspection program, including the purchase, care, and 9 handling of at least two fireworks- or explosive-sniffing dogs. 10 The sums appropriated shall be expended by the department 11 of law enforcement for the purposes of this Act. 12 SECTION 5. New statutory material is underscored. 13 SECTION 6. This Act shall take effect on July 1, 2025. 14
