A BILL FOR AN ACT

RELATING TO CLIMATE CHANGE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the office of
- 2 planning and sustainable development, rather than the department
- 3 of land and natural resources, is best equipped to effectively
- 4 administer the Hawaii climate change mitigation and adaptation
- 5 commission. The office of planning and sustainable development
- 6 is responsible for supporting the principles of the State
- 7 Planning Act, including state priorities for climate change
- 8 adaptation, and leads the State's coordination of sea level rise
- 9 adaptation activities.
- 10 The legislature further finds that the office of planning
- 11 and sustainable development is charged with coordinating
- 12 activities across levels of government and ensuring cooperation
- 13 to reach the State's goals. The legislature recognizes that
- 14 comprehensive, coordinated action is necessary to combat the
- 15 impacts of climate change.
- 16 Accordingly, to promote public safety, efficiency, and
- 17 effectiveness, the purpose of this Act is to transfer the Hawaii



- 1 climate change mitigation and adaptation commission from the
- 2 department of land and natural resources to the office of
- 3 planning and sustainable development for administrative
- 4 purposes.
- 5 SECTION 2. Section 225P-3, Hawaii Revised Statutes, is
- 6 amended as follows:
- 7 1. By amending subsection (a) to read:
- 8 "(a) There is established the Hawaii climate change
- 9 mitigation and adaptation commission that shall be placed within
- 10 the [department of land and natural resources] office of
- 11 planning and sustainable development for administrative purposes
- 12 only.":
- 13 2. By amending subsection (c) to read:
- "(c) The commission shall include the following members:
- 15 (1) The chairs of the standing committees of the
- 16 legislature with subject matter jurisdiction
- 17 encompassing environmental protection and land use;
- 18 (2) The chairperson of the board of land and natural
- resources or the chairperson's designee, who shall be
- the co-chair of the commission;

| 5 | SECTION 3. All rights, powers, functions, and duties of | | |

- 6 civil service employee without the loss of salary, seniority,
- 7 prior service credit, vacation, sick leave, or other employee
- 8 benefits or privileges and without the necessity of examination;
- 9 provided that such officer or employee possesses the minimum
- 10 qualifications for the position to which transferred or
- 11 appointed.
- 12 If an office or position held by an officer or employee
- 13 having tenure is abolished, the officer or employee shall not
- 14 thereby be separated from public employment, but shall remain in
- 15 the employment of the State with the same pay and classification
- 16 and shall be transferred to some other office or position for
- 17 which the officer or employee is eligible under the personnel
- 18 laws of the State as determined by the head of the department or
- 19 the governor.
- 20 SECTION 4. All appropriations, records, equipment,
- 21 machines, files, supplies, contracts, books, papers, documents,

- 1 maps, and other personal property heretofore made, used,
- 2 acquired, or held by the department of land and natural
- 3 resources relating to the functions transferred to the office of
- 4 planning and sustainable development shall be transferred with
- 5 the functions to which they relate.
- 6 SECTION 5. Statutory material to be repealed is bracketed
- 7 and stricken. New statutory material is underscored.
- 8 SECTION 6. This Act shall take effect on January 1, 2050.
