A BILL FOR AN ACT

RELATING TO SCHOOL MEALS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Hawaii's working
- 2 families face significant economic challenges, including the
- 3 rising cost of living, inflation, and limited affordable options
- 4 for basic needs. Access to nutritious meals is essential for
- 5 the overall well-being of Hawaii's people. Further, for
- 6 students, access to healthy meals is critical to academic
- 7 success and achievement. However, for some students, school
- 8 meals may be their only consistent source of food.
- 9 The legislature also finds that Aloha United Way released
- 10 the asset limited, income constrained, employed (ALICE) report
- 11 in January 2025, which identified that, while twelve per cent of
- 12 households in the State are below the poverty line, twenty-nine
- 13 per cent are identified as ALICE households. ALICE households
- 14 are defined as households with incomes above the federal poverty
- 15 level but continue to struggle with the bare-minimum costs of
- 16 basic necessities such as housing, childcare, food,
- 17 transportation, health care, and a smartphone plan, plus taxes.

- 1 The report also found that forty-six per cent of ALICE
- 2 households experience consistent food insecurity.
- 3 The legislature further finds that subsidizing the meal
- 4 costs for ALICE households will have the benefit of providing
- 5 support to families in need. Additionally, subsidized meal
- 6 costs for students will allow students to focus on their
- 7 academic careers, extracurricular activities, and life goals.
- 8 Meal subsidies at department of education schools will allow
- 9 more students to achieve a high-quality education while ensuring
- 10 adequate nutrition for physical development and mental well-
- 11 being.
- 12 Accordingly, the purpose of this Act is to:
- 13 (1) Require the department of education to adopt
- 14 administrative rules to provide a lower rate or free
- meals to students based on their economic need; and
- 16 (2) Appropriate funds to the department of education to
- 17 subsidize meal costs for students whose families
- qualify as ALICE households.
- 19 SECTION 2. The department of education shall adopt
- 20 administrative rules pursuant to chapter 91, Hawaii Revised

- 1 Statutes, to provide a lower rate or free meals to students
- 2 based on their economic need pursuant to this Act.
- 3 SECTION 3. There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$ or so
- 5 much thereof as may be necessary for fiscal year 2025-2026 and
- 6 the same sum or so much thereof as may be necessary for fiscal
- 7 year 2026-2027 for meal subsidies for students at department of
- 8 education schools whose families are classified as asset
- 9 limited, income constrained, employed (ALICE) households.
- 10 The sums appropriated shall be expended by the department
- 11 of education for the purposes of this Act.
- 12 SECTION 4. This Act shall take effect on July 1, 2050.
