RELATING TO THE OFFENSE OF PROMOTING PORNOGRAPHY FOR MINORS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the prevention of
- 2 sexual exploitation and abuse of children is a government
- 3 objective of paramount importance, and this objective extends to
- 4 blocking dissemination of pornographic materials to children.
- 5 To improve the ability to prosecute those who promote
- 6 pornography for minors, Act 244, Session Laws of Hawaii 2024,
- 7 specifically permits the prosecution of the offense of promoting
- 8 pornography for minors through undercover operations.
- 9 The legislature further finds that large-scale undercover
- 10 operations have proven to be an effective tool in reducing and
- 11 combating offenders who solicit minors to engage in sexual
- 12 activities on the internet. Expeditious charging is crucial
- 13 during these large-scale operations. Main charges brought from
- 14 these operations, the offenses of electronic enticement of a
- 15 child under sections 707-756 and 707-757, Hawaii Revised
- 16 Statutes, and the offense of commercial sexual exploitation of a
- 17 minor under section 712-1209, Hawaii Revised Statutes, can be

DEPARTMENT: Attorney General

TITLE: A BILL FOR AN ACT RELATING TO THE OFFENSE OF

PROMOTING PORNOGRAPHY FOR MINORS.

PURPOSE: To authorize the offense of Promoting

Pornography for Minors to be instituted by

written information.

MEANS: Amend section 806-83(a), Hawaii Revised

Statutes (HRS).

JUSTIFICATION: The Department of the Attorney General's

Internet Crimes Against Children Task Force regularly conducts Operation Keiki Shield operations, where undercover law enforcement officers pose as minors on the internet to identify, locate, arrest, and prosecute offenders who solicit minors to engage in

sexual activities on the Internet.

Undercover officers often receive pornographic materials during these operations, and in response, the Legislature enacted Act 244, Session Laws of Hawaii 2024 (Act 244), specifically extending the criminal offense of Promoting Pornography for Minors (section 712-1215, HRS) to persons who disseminate pornographic materials to an undercover law enforcement officer who poses as a minor.

Expeditious charging is crucial during these large-scale operations. The main charges initiated from these operations are the criminal offenses of Electronic Enticement of a Child (sections 707-756 and 707-757, HRS) and Commercial Sexual Exploitation of a Minor (section 712-1209.1, HRS), both of which can be instituted by way of written information. Therefore, to enhance the effectiveness of Act 244, this bill seeks to amend section 806-83, HRS, to allow the offense of Promoting Pornography for Minors to be instituted via written information.

SB. NO. 1313

Impact on the public: This bill will have a positive impact on the public with a goal of reducing pornographic materials being distributed to minors.

Impact on the department and other agencies: This bill will greatly assist prosecutions of offenders who disseminate pornographic

materials to minors.
