- 3 SECTION 14. Funds appropriated or authorized by this Act
- 4 that are not expended or encumbered by June 30, 2026, and
- 5 June 30, 2027, of the respective fiscal years, shall lapse as of
- 6 those dates.
- 7 SECTION 15. In accordance with section 9 of article VII of
- 8 the Constitution of the State of Hawaii and sections 37-91 and
- 9 37-93, Hawaii Revised Statutes, the legislature has determined
- 10 that the state general fund expenditure ceiling for fiscal year
- 11 2025-2026 has already been exceeded by \$8,551,796 or 1 per
- 12 cent. In addition, the appropriations contained in this Act
- 13 will cause the state general fund expenditure ceiling for fiscal
- 14 year 2025-2026 to be further exceeded by \$ or 1 per
- 15 cent. The reasons for exceeding the general fund expenditure
- 16 ceiling are that the appropriations made in this Act are
- 17 necessary to serve the public interest and to meet the needs
- 18 addressed by this Act.
- 19 SECTION 16. This Act shall take effect on July 1, 2050.
