7	SECTION 6. Funds appropriated or authorized by this Act			
8	that are not expended or encumbered by June 30, 2026, and June			
9	30, 2027, of the respective fiscal years, shall lapse as of			
10	those dates.			
11	SECTION 7. In accordance with section 9 of article VII of			
12	the Constitution of the State of Hawaii and sections 37-91 and			
13	37-93, Hawaii Revised Statutes, the legislature has determined			
14	that the state general fund expenditure ceiling for fiscal year			
15	2025-2026 has already been exceeded by \$8,551,796 or one per			
16	cent. In addition, the appropriations contained in this Act			
17	will cause the state general fund expenditure ceiling for fiscal			
18	year 2025-2026 to be further exceeded by \$, or one per			
19	cent. The reasons for exceeding the general fund expenditure
