3 SECTION 14. Funds appropriated or authorized by this Act
4 that are not expended or encumbered by June 30, 2026, and
5 June 30, 2027, of the respective fiscal years, shall lapse as of
6 those dates.

7 SECTION 15. In accordance with section 9 of article VII of 8 the Constitution of the State of Hawaii and sections 37-91 and 9 37-93, Hawaii Revised Statutes, the legislature has determined 10 that the state general fund expenditure ceiling for fiscal year 2025-2026 has already been exceeded by \$8,551,796 or one per 11 cent. In addition, the appropriations contained in this Act 12 will cause the state general fund expenditure ceiling for fiscal 13 year 2025-2026 to be further exceeded by \$, or one per. 14 cent. The reasons for exceeding the general fund expenditure 15 ceiling are that the appropriations made in this Act are 16 17 necessary to serve the public interest and to meet the needs addressed by this Act. 18

SECTION 16. This Act shall take effect on July 1, 2050.
