- 1 SECTION 5. Salary increases and cost adjustments provided
- 2 in this Act for any officer or employee whose compensation is
- 3 paid, in whole or in part, from federal, special, or other funds
- 4 shall be paid wholly or proportionately, as the case may be,
- 5 from the respective funds.
- 6 SECTION 6. Funds appropriated or authorized by this Act
- 7 that are not expended or encumbered by June 30, 2026, and
- 8 June 30, 2027, of the respective fiscal years, shall lapse as of
- 9 those dates.
- 10 SECTION 7. In accordance with section 9 of article VII of
- 11 the Constitution of the State of Hawaii and sections 37-91 and
- 12 37-93, Hawaii Revised Statutes, the legislature has determined
- 13 that the state general fund expenditure ceiling for fiscal year
- 14 2025-2026 has already been exceeded by \$8,551,796 or one per
- 15 cent. In addition, the appropriations contained in this Act
- 16 will cause the state general fund expenditure ceiling for fiscal
- 17 year 2025-2026 to be further exceeded by \$, or one per
- 18 cent. The reasons for exceeding the general fund expenditure
- 19 ceiling are that the appropriations made in this Act are
- 20 necessary to serve the public interest and to meet the needs
- 21 addressed by this Act.

1 SECTION 8. This Act shall take effect on July 1, 2050.
