A BILL FOR AN ACT

RELATING TO EMERGENCY AEROMEDICAL SERVICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that most rural
- 2 communities in the State have fewer health care resources
- 3 compared to communities on Oahu, including access to advanced
- 4 levels of trauma care, medical specialists, and sub-specialists.
- 5 This puts patients in these areas at greater risk of poor
- 6 outcomes for serious medical conditions such as heart attack,
- 7 stroke, and traumatic bodily injuries.
- 8 The legislature further finds that the existing aeromedical
- 9 services system is overburdened. The State is currently served
- 10 by only one statewide aeromedical provider, for which there are
- 11 few viable and cost-effective alternatives in the event of a
- 12 grounding, for example, due to maintenance issues or crew
- 13 availability. Emergency aeromedical services are not available
- 14 for many patients in rural counties and areas.
- The legislature further finds that one model to improve
- 16 emergency aeromedical services could be based on the county of
- 17 Maui's medevac service model. Act 2, Special Session Laws of

- 1 Hawaii 2003, appropriated general funds for the provision of
- 2 emergency aeromedical helicopter services for the county of
- 3 Maui. Act 213, Session Laws of Hawaii 2007, appropriated
- 4 general funds for a replacement helicopter for the county of
- 5 Maui aeromedical emergency medical services program. The
- 6 department of health cost-shares a helicopter with the county of
- 7 Maui and contracts with a private entity to provide staff and
- 8 operate the helicopter for emergency aeromedical services.
- 9 The legislature further finds that the department of health
- 10 has the authority to establish emergency aeromedical services
- 11 but lacks sufficient resources to implement the Maui model in
- 12 other rural counties. Accordingly, the purpose of this Act is
- 13 to appropriate funds to increase the availability of emergency
- 14 aeromedical services.
- 15 SECTION 2. There is appropriated out of the general
- 16 revenues of the State of Hawaii the sum of \$ or so
- 17 much thereof as may be necessary for fiscal year 2025-2026 and
- 18 the same sum or so much thereof as may be necessary for fiscal
- 19 year 2026-2027 to assist the counties, other than the county of
- 20 Kalawao, to increase access to emergency aeromedical services,
- 21 to be allocated as follows:

to the city and county of Honolulu; 1 (1) \$ 2 (2) \$ to the county of Maui; 3 (3) \$ to the county of Hawaii; and to the county of Kauai. (4) \$ 5 The sums appropriated shall be expended by each county for 6 the purposes of this Act. 7 SECTION 3. There is appropriated out of the general revenues of the State of Hawaii the sum of \$ 8 9 much thereof as may be necessary for fiscal year 2025-2026 and 10 the same sum or so much thereof as may be necessary for fiscal 11 year 2026-2027 to be deposited into the emergency medical 12 services special fund. 13 SECTION 4. There is appropriated out of the emergency 14 medical services special fund the sum of \$ or so much 15 thereof as may be necessary for fiscal year 2025-2026 and the 16 same sum or so much thereof as may be necessary for fiscal year 17 2026-2027 for the establishment of and operating expenses for
