A BILL FOR AN ACT

RELATING TO YOUTH MENTAL HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that, according to a
 2 ten-year study by the Centers for Disease Control and
 3 Prevention, nearly all indicators of children and adolescent
- 4 mental health have worsened between 2013 and 2023. Disasters
- 5 like the COVID-19 pandemic and the Maui wildfires in August 2023
- 6 have increased rates of depression and anxiety in our youth.
- 7 The legislature further finds that prevention activities
- 8 related to the promotion of mental health, such as early
- 9 intervention, mental health education, and coping strategies,
- 10 are critical to preventing the escalation of mental health
- 11 disorders in the State's communities, potentially reducing the
- 12 need for more intensive services in the future.
- 13 Digital platforms that can be accessed with mobile devices
- 14 can provide a powerful public health service, especially for
- 15 youth, by:
- 16 (1) Expanding the reach of mental health education and
- 17 prevention by making it more convenient and inclusive,

		especially for children and adorescents in remote of
2		underserved areas where in-person programs may be
3		limited;
4	(2)	Reducing stigma by making it easier for youth to
5		explore resources without fear of judgment;
6	(3)	Enhancing engagement and interactivity by allowing
7		youth to guide their own learning;
8	(4)	Tailoring content to the needs of the user;
9	(5)	Providing a cost-effective way to reach a large
10		audience;
11	(6)	Addressing lower-level needs so the behavioral health
12		workforce, which is scarce, can focus on youth with
13		the highest level of need;
14	(7)	Providing information that is continuously updated to
15		reflect the latest research and resources; and
16	(8)	Collecting critical data about community mental health
17		needs.
18	Acco	rdingly, the purpose of this Act is to establish a
19	digital y	outh mental health platform pilot project under which
20	the child	and adolescent mental health division of the
21	departmen	t of health shall develop and make publicly available a

- 3 SECTION 2. (a) The child and adolescent mental health
- 4 division of the department of health shall implement and
- 5 administer a digital youth mental health platform pilot project.
- 6 The pilot project shall commence on July 1, 2025, and end on
- 7 June 30, 2027.
- 8 (b) Under the pilot project, the child and adolescent
- 9 mental health division shall contract for the following
- 10 services:
- 11 (1) Development, management, and hosting services for the
- digital youth mental health platform. The child and
- 13 adolescent mental health division shall oversee the
- development of the platform that is evidence-based,
- peer-reviewed, confidential, and responsive. The
- platform shall provide:
- 17 (A) County specific resources;
- 18 (B) Mental health education;
- 19 (C) Self-care strategies;
- 20 (D) Healthy coping strategies; and

1		(E)	Data regarding mental health needs in the State;
2			and
3	(2)	Comm	nunication and marketing services. The child and
4		adol	escent mental health division shall manage the
5		comm	unications and marketing services, which include:
6		(A)	Development of a communications and marketing
7			plan;
8		(B)	Creation of ad campaign materials inclusive of
9			print, radio, digital, and television ads and the
10			respective media buys;
11		(C)	Planning and management of community and outreach
12			events; and
13		(D)	Social media campaign and management.
14	(c)	The	procurement of the development, management, and
15	hosting se	ervic	es and the communication and marketing services
16	for the p	ırpos	es of this Act shall be exempt from chapters 103D
17	and 103F,	Hawa	ii Revised Statutes.
18	(d)	No 1	ater than twenty days prior to the convening of
19	the regula	ar se	ssions of 2026 and 2027, the child and adolescent
20	mental hea	alth ·	division shall submit to the legislature a report

- 1 of its findings and recommendations regarding the digital youth
- 2 mental health platform pilot project.
- 3 SECTION 3. There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$ or so
- 5 much thereof as may be necessary for fiscal year 2025-2026, and
- 6 the sum of \$ or so much thereof as may be necessary
- 7 for fiscal year 2026-2027, for the implementation and
- 8 administration of the digital youth mental health platform pilot
- 9 project.
- 10 The sums appropriated shall be expended by the department
- 11 of health for the purposes of this Act.
- 12 SECTION 4. This Act shall take effect on July 1, 2025.
