A BILL FOR AN ACT

RELATING TO THE WAGE AND HOUR LAW.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 387, Hawaii Revised Statutes, is
- 2 amended by adding three new sections to be appropriately
- 3 designated and to read as follows:
- 4 "§387-A Order of wage payment violation; appeal. (a)
- 5 When the department, as a result of the department's own
- 6 investigation, finds that a violation of this chapter or
- 7 administrative rules adopted under this chapter has been
- 8 committed and not corrected, the department shall issue an order
- 9 of wage payment violation to the employer in violation. The
- 10 order shall include any amount assessed pursuant to section
- 11 387-12(a).
- 12 (b) The order of wage payment violation shall be final and
- conclusive unless within twenty days after a copy of the order 13
- 14 of wage payment violation has been sent to the employer, the
- 15 employer files a written notice of appeal with the director in
- 16 writing.

1 (c) A hearing on the written notice of appeal shall be 2 held pursuant to chapter 91, by a hearings officer appointed by 3 the director, within thirty days of the filing of the notice of appeal. A decision stating the findings of fact and conclusions 4 5 of law shall be rendered by the hearings officer within thirty 6 days after the conclusion of the hearing. 7 (d) Any party to an appeal under this chapter may obtain judicial review of the decision issued by the hearings officer 8 9 in the manner provided under chapter 91. 10 §387-B Remittance of penalties. Until the order of wage payment violation becomes final, the director may withdraw or 11 12 modify the order of wage payment violation or remit all or any part of a penalty assessed if good cause is shown; provided that 13 14 the employer in default complies with this chapter and the administrative rules adopted under this chapter. 15 §387-C Enforcement of the order of wage payment violation. 16 **17** The director may file in any court of competent jurisdiction in 18 the jurisdiction in which the employer does business, a certified copy of the final order of wage payment violation. 19 20 The court shall render a judgment in accordance with the final 21 order of wage payment violation and notify the parties of the

2 proceedings in relation to the judgment shall be the same, as 3 though the judgment had been rendered in an action duly heard 4 and determined by the court, except that there shall be no 5 appeal from the judgment." 6 SECTION 2. - 1 SECTION 3. Section 387-1, Hawaii Revised Statutes, is
- 2 amended by amending the definition of "wage" to read as follows:
- 3 ""Wage" means (except as the department may provide under
- 4 section 387-11) legal tender of the United States or checks on
- 5 banks convertible into cash on demand at full face value thereof
- 6 as compensation for labor or services rendered by an employee,
- 7 whether the amount is determined on a time, task, piece,
- 8 commission, or other basis of calculation, and in addition
- 9 thereto the reasonable cost as determined by the department, to
- 10 the employer of furnishing an employee with board, lodging, or
- 11 other facilities if [such] the board, lodging, or other
- 12 facilities are customarily furnished by such employer to the
- 13 employer's employees. Except for the purposes of the last
- 14 sentence of section 387-2, "wage" shall not include tips or
- 15 gratuities of any kind."
- 16 SECTION 4. Section 387-12, Hawaii Revised Statutes, is
- 17 amended to read as follows:
- 18 "§387-12 Penalties; collection of unpaid wages;
- 19 injunctions; etc. (a) Civil. Any employer who fails to pay
- 20 wages in accordance with this chapter without equitable

14	section 706-640, be subject to a fine of not less than
15	\$500 per offense; provided that each violation shall

17	[(b) Liability to employee. Any employer who violates any
18	provision of sections 387 2 and 387 3 shall be liable to the
19	employee or employees affected in the amount of their unpaid
20	minimum wages or unpaid overtime compensation, and in case of

- 3 (c) Collection suits; attorney's fee; assignments; relief
- 4 from costs. Action to recover [such] liability may be
- 5 maintained in any court of competent jurisdiction by any one or
- 6 more employees for and in behalf of oneself or themselves and
- 7 other employees similarly situated, or the employee or employees
- 8 may designate an agent or representative to maintain action for
- 9 and in behalf of all employees similarly situated. The court in
- 10 [such] the action shall, in addition to any judgment awarded to
- 11 the plaintiff or plaintiffs, in the event the plaintiff or
- 12 plaintiffs prevail, allow a reasonable attorney's fee to be paid

- 16 (1) Whenever it appears to the director that any employer
- is engaged in any act or practice [which] that

- 19 chapter, or of any regulation, the director may in the
- director's discretion bring an action in the circuit
- 21 court of the circuit in which it is charged the act or

11	(e)	Restitution of illegal deductions; effect of.	
12	Whenever	in the course of an inspection made for the purposes of	
13	this chapter it is determined that there has been an illegal		
14	deduction of wages under chapter 388, the director or the		
15	director's authorized representative may secure restitution of		
16	[such] the deductions. If the restitution is made, no		
17	prosecution under chapter 388 shall be instituted or		
18	maintained."		
19	SECTION 5. This Act does not affect rights and duties tha		
20	matured,	penalties that were incurred, and proceedings that were	
21	begun before its effective date.		

- 1 SECTION 6. In codifying the new sections added by section
- 2 1 and referenced in section 2 of this Act, the revisor of
- 3 statutes shall substitute appropriate section numbers for the
- 4 letters used in designating or referring to the new sections in
- 5 this Act.
- 6 SECTION 7. Statutory material to be repealed is bracketed
- 7 and stricken. New statutory material is underscored.

DLIR; Order of Wage Payment Violation; Wage and Hour Law; Enforcement; Penalties

Description:

Requires the Department of Labor and Industrial Relations to issue an order of wage payment violation to employers found to be in violation of the State's Wage and Hour Law. Establishes penalties, enforcement, and appeal procedures. Amends the definition of "wage" to clarify that it means compensation for labor or services rendered by an employee, regardless of how it is calculated. (SD1)
