A BILL FOR AN ACT

RELATING TO WORKFORCE DEVELOPMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that education and 2 vocational training are the cornerstones of professional 3 development for students seeking job opportunities and career 4 development throughout the State. The Hawaii P-20 partnerships 5 for education advisory council and its associated members from 6 the executive office on early learning, department of education, 7 and university of Hawaii, including the university of Hawaii 8 community colleges, collaborate to improve educational pathways 9 from early childhood through higher education to imbue students 10 with vocational skills and knowledge that will prepare them for 11 careers and develop them as leaders within the community. This 12 cooperation is vital to foster economic growth and stability.

13 The legislature further finds that longstanding vacancies 14 within the state workforce have created challenges for state 15 departments seeking to fill positions with qualified candidates. 16 Accordingly, the Hawaii P-20 partnerships for education aims to 17 fulfill vocational needs for these departments. To meet these



1 goals, it is imperative that the P-20 partnerships for education 2 work closely with state departments such as the department of 3 labor and industrial relations; department of human resources 4 development; department of business, economic development, and 5 tourism; the university of Hawaii system, including the 6 university of Hawaii community colleges; and the department of 7 education.

8 The legislature further finds that creating a performance 9 metric to measure the development of P-20 partnerships for 10 education programs will promote accountability in state spending, ensuring that state appropriations are used 11 12 responsibly and efficiently toward meeting program initiatives. 13 The legislature also finds that requiring the Hawaii P-20 14 partnerships for education office within the university of 15 Hawaii to establish and implement evidence-based assessment of 16 its workforce and pathway development programs is a matter of 17 statewide concern pursuant to article X, section 6, of the 18 Hawaii State Constitution.

19 The purpose of this Act is to establish and implement20 evidence-based performance metrics for the Hawaii P-20

partnerships for education to allow better evidence-based

 SECTION 2. Chapter 304A, Hawaii Revised Statutes, is
 amended by adding a new part to be appropriately designated and
 to read as follows:

6 "PART . HAWAII P-20 PARTNERSHIPS FOR EDUCATION
7 §304A- Hawaii P-20; performance metrics evaluation
8 program; established. (a) The Hawaii P-20 partnerships for
9 education shall establish and implement evidence-based
10 assessments of its workforce and pathway development programs
11 for Hawaii students, as provided in this section.

(b) The Hawaii P-20 partnerships for education shall
create and maintain records of standardized performance metrics
relating to the outcomes of its workforce and pathway
development programs, including the number of students utilizing
those pathways to fill to public sector job vacancies and
vacancies in the State's private sector workforce.

1 (3) Department of business, economic development, and tourism; 2 (4) University of Hawaii system, including the university 3 4 of Hawaii community colleges; and 5 (5) Department of education, 6 to develop the metrics and standards used to measure the 7 performance-based outcomes required under this section to ensure 8 alignment with the vocational and economic goals of the P-20 9 partnerships for education program. 10 (d) Funds appropriated to P-20 partnerships for education 11 may be transferred to other state departments or agencies in accordance with the performance-metrics and outcomes relating to 12 13 student achievement, degree attainment, and the number or 14 percentage of jobs in career paths that lead to living wage 15 positions. 16 (e) Any amount under subsection (d) that is not 17 transferred to another program shall lapse to the general fund

18 at the end of the fiscal year.

(f) No later than thirty days prior to the convening of
each regular session, the Hawaii P-20 partnerships for education
advisory council shall submit a report to the legislature that

20	and implement evidence-based assessments of its workforce and	
21	pathway d	evelopment programs.



1	The sums appropriated or authorized shall be expended by
2	the university of Hawaii for the purposes of this Act.
3	SECTION 4. This Act shall take effect on July 31, 2050.
