1 SECTION 1. The legislature finds that there is currently one location in the State for newly graduated nursing students 2 to take the National Council Licensure Examination (NCLEX) 3 4 administered by Pearson Education, Inc., to obtain their license. The limitation of the testing sites places a 5 6 significant burden on many new graduates who are requested to 7 pay for lodging, travel, and other related costs to take the 8 test on Oahu. i 9 Accordingly, the purpose of this Act is to require the 10 state board of nursing to establish one Pearson VUE Authorized 11 Test Center in each of the counties of Hawaii, Kauai, and Maui
