A BILL FOR AN ACT

RELATING TO FITNESS TO PROCEED.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. (a) The department of corrections and
2 rehabilitation shall establish a five-year fitness to proceed
3 pilot program to help reduce overcrowding at the Hawaii state
4 hospital and ensure the safety of the hospital's staff and
5 personnel while an inmate is incapacitated or awaiting a
6 determination on the inmate's fitness to proceed pursuant to
7 chapter 704, Hawaii Revised Statutes.

8 (b) For purposes of the pilot program, the department of
9 corrections and rehabilitation shall reserve at least one cell
10 or personal living space to accommodate every two inmates who
11 have filed a motion or cited a defense pursuant to chapter 704,
12 Hawaii Revised Statutes.

13 (c) An inmate housed in a reserved cell or living space
14 shall be the joint responsibility of the department of
15 corrections and rehabilitation and department of health until:

16 (1) The inmate is no longer incapacitated, as determined
17 by the department of health; or



1 (2) A determination is made regarding the inmate's fitness
2 to proceed pursuant to chapter 704, Hawaii Revised
3 Statutes;
4 whichever occurs later.

5 (d) The department of corrections and rehabilitation shall
6 submit an interim report to the legislature on the status of the
7 pilot program no later than twenty days prior to the convening
8 of the regular session of 2027 and a final report of its
9 findings and recommendations, including any proposed
10 legislation, no later than twenty days prior to the convening of
11 the regular session of 2030.

12 SECTION 2. There is appropriated out of the general
13 revenues of the State of Hawaii the sum of \$ or so much
14 thereof as may be necessary for fiscal year 2025-2026 and the
15 same sum or so much thereof as may be necessary for fiscal year
16 2026-2027 for the establishment and implementation of the
17 fitness to proceed pilot program.

18 The sums appropriated shall be expended by the department
19 of corrections and rehabilitation for the purposes of this Act.


