SECTION 7. All rights, powers, functions, and duties of
the Hawaii film office are transferred to the Hawaii film
authority.

All employees who occupy civil service positions and whose 4 functions are transferred to the Hawaii film authority by this 5 Act shall retain their civil service status, whether permanent 6 or temporary. Employees shall be transferred without loss of 7 salary, seniority (except as prescribed by applicable collective 8 bargaining agreements), retention points, prior service credit, 9 any vacation and sick leave credits previously earned, and other 10 rights, benefits, and privileges, in accordance with state 11 personnel laws and this Act; provided that the employees possess 12 the minimum qualifications and public employment requirements 13 for the class or position to which transferred or appointed, as 14 applicable; provided further that subsequent changes in status 15 16 may be made pursuant to applicable civil service and 17 compensation laws.

18 Any employee who, prior to this Act, is exempt from civil 19 service and is transferred as a consequence of this Act may 20 retain the employee's exempt status, but shall not be appointed 21 to a civil service position as a consequence of this Act. An

exempt employee who is transferred by this Act shall not suffer 1 any loss of prior service credit, vacation or sick leave credits 2 previously earned, or other employee benefits or privileges as a 3 consequence of this Act; provided that the employees possess 4 legal and public employment requirements for the position to 5 which transferred or appointed, as applicable; provided further 6 that subsequent changes in status may be made pursuant to 7 applicable employment and compensation laws. The director of 8 business, economic development, and tourism may prescribe the 9 duties and qualifications of these employees and fix their 10 salaries without regard to chapter 76, Hawaii Revised Statutes. 11 SECTION 8. All appropriations, records, equipment, 12 machines, files, supplies, contracts, books, papers, documents, 13 maps, and other personal property heretofore made, used, 14 acquired, or held by the Hawaii film office relating to the 15 16 functions transferred to the Hawaii film authority shall be transferred with the functions to which they relate. 17 SECTION 9. In codifying the new sections added by section 18 1 of this Act, the revisor of statutes shall substitute 19 20 appropriate section numbers for the letters used in designating

21 the new sections in this Act.

Establishes the Hawaii Film Authority within the Department of Business, Economic Development, and Tourism and transfers the rights, powers, functions, and duties of the Hawaii Film Office to the Authority. Establishes the Hawaii Film Authority Board within the Hawaii Film Authority. Establishes the Film Industry and Development Special Fund. Renames the Hawaii Film and Creative Industries Development Special Fund as the Hawaii Creative Industries Development Special Fund and excludes media and film from the definition of creative industries. Allows the Creative Industries Development Special Fund to be used for the support and development of facilities and other initiatives to grow the State's creative industries. Requires annual reports to the Legislature. Appropriates funds. Effective 7/1/3000. (HD2)
