A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF TRANSPORTATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 261-4.5, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "[+]\$261-4.5[+] Biosecurity[, inspection, and]; fireworks;
- 4 inspections; cargo support facilities. (a) The department
- 5 shall coordinate with the department of agriculture to
- 6 facilitate the inspection, consolidation, deconsolidation, and
- 7 treatment of imported and exported agriculture and other
- 8 inspected commodities to meet the needs of each island and to
- 9 facilitate the safe movement of enplaned and deplaned air cargo
- 10 through the airports.
- 11 (b) The department shall install and use at each state
- 12 airport electronic equipment capable of scanning air cargo
- 13 container loads to detect illegal fireworks."
- 14 SECTION 2. Section 266-21.5, Hawaii Revised Statutes, is
- 15 amended to read as follows:
- "[f]\$266-21.5[f] Biosecurity[, inspection, and];
- 17 fireworks; inspections; cargo support facilities. (a) The



- 1 department of transportation shall provide space at commercial
- 2 harbors for biosecurity and inspection facilities and to
- 3 facilitate the safe and efficient movement of maritime cargo
- 4 through the commercial harbors.
- 5 (b) The department of transportation and department of
- 6 agriculture shall plan, design, and construct biosecurity,
- 7 inspection, consolidation, deconsolidation, and treatment
- 8 facilities for use by the department of agriculture to enhance
- 9 the efficient and safe movement of imported and exported marine
- 10 cargo, to include food [+]safety[+] and food security guidelines
- 11 and standards.
- 12 (c) The department of transportation shall install and use
- 13 at each commercial harbor electronic equipment capable of
- 14 scanning cargo container loads to detect illegal fireworks."
- 15 SECTION 3. Statutory material to be repealed is bracketed
- 16 and stricken. New statutory material is underscored.
- 17 SECTION 4. This Act shall take effect upon its approval.
