A BILL FOR AN ACT

RELATING TO TRANSPORTATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 264, Hawaii Revised Statutes, is
- 2 amended by adding a new part to be appropriately designated and
- 3 to read as follows:
- 4 "PART . TOLL ROADS AND TOLL CHARGES
- 5 §264-A Toll roads; toll charges; designation of existing
- 6 state highways. (a) The director of transportation may:
- 7 (1) Designate as a toll road any existing state highway or
- 8 any portion thereof; and
- 9 (2) Impose toll charges for the use of any toll road
- designated pursuant to this section.
- 11 (b) The department of transportation shall adopt rules
- 12 pursuant to chapter 91 to effectuate the purpose of this
- 13 section.
- 14 §264-B Toll road; toll charges; Hana highway. The
- 15 director of transportation shall designate as a toll road, and
- 16 impose toll charges for the use of, the portion of Hana highway
- 17 from mile marker thirty-two to mile marker forty."

Report Title:

DOT; Toll Roads; Toll Charges; Hana Highway

Description:

Authorizes the Director of Transportation to designate as a toll road, and impose toll charges for the use of, any existing state highway. Requires the Director of Transportation to designate as a toll road a certain portion of Hana Highway. Requires the Department of Transportation to develop a plan to exempt resident vehicle operators from the imposition of toll charges for the use of Hana Highway.
