A BILL FOR AN ACT

PROPOSING AN AMENDMENT TO THE HAWAII CONSTITUTION TO PROTECT THE RIGHT TO CONTRACEPTION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the Constitution of
- 2 the State of Hawaii must support an individual's ability to make
- 3 personal decisions about one's own body and medical care through
- 4 the explicit protection of the right to access contraceptives
- 5 and engage in contraception. This right includes the right of
- 6 each person's health care provider to provide contraceptives,
- 7 contraception, and information, referrals, and services related
- 8 to contraception.
- 9 The term "contraception" generally means an action taken to
- 10 prevent pregnancy, including the use of contraceptives or
- 11 fertility-awareness-based methods and sterilization procedures.
- 12 The term "contraceptive" generally means any drug, device, or
- 13 biological product intended for use in the prevention of
- 14 pregnancy, whether specifically intended to prevent pregnancy or
- 15 for other health needs, that is approved, cleared, authorized,
- 16 or licensed under federal law. Contraceptives include

- 1 intrauterine devices (IUDs) and emergency contraceptives, such
- 2 as levonorgestrel (Plan B), ulipristal acetate (Ella), and the
- 3 emergency application of IUDs, that work by preventing pregnancy
- 4 and not, as some mistakenly believe, by terminating a pregnancy,
- 5 stopping the implantation of a fertilized egg, or affecting the
- 6 developing embryo.
- 7 The legislature further finds that fourteen
- 8 states California, Colorado, Florida, Illinois, Massachusetts,
- 9 Michigan, Minnesota, New Jersey, New Mexico, Ohio, Oregon, Rhode
- 10 Island, Vermont, and Washington plus Washington D.C. have
- 11 statutory or constitutional protections for the right to
- 12 contraception.
- 13 The purpose of this Act is to propose an amendment to
- 14 article I of the Constitution of the State of Hawaii to protect
- 15 a person's right to seek and obtain contraceptives and to engage
- 16 in contraception. The proposed amendment is intended to further
- 17 the right to privacy guaranteed by section 6 of article I of the
- 18 Constitution of the State of Hawaii and is not intended to
- 19 narrow or limit the constitutional right to privacy.

1	SECTION 2. Article I of the Constitution of the State of
2	Hawaii is amended by adding a new section to be appropriately
3	designated and to read as follows:
4	"CONTRACEPTION
5	Section . No law shall be enacted, nor any state
6	action taken, that denies or interferes with a person's right to
7	obtain contraceptives or voluntarily engage in contraception."
8	SECTION 3. The question to be printed on the ballot shall
9	be as follows:
10	"Shall the Constitution of the State of Hawaii be
11	amended to provide that no law shall be enacted, nor any
12	state action taken, that denies or interferes with a
13	person's right to obtain contraceptives or voluntarily
14	engage in contraception?"
15	SECTION 4. New constitutional material is underscored.
16	SECTION 5. This amendment shall take effect upon
17	compliance with article XVII, section 3, of the Constitution of
18	the State of Hawaii.
