A BILL FOR AN ACT

RELATING TO AGRICULTURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that article XI,
- 2 section 1 of the Hawaii State Constitution mandates that the
- 3 State "conserve and protect Hawaii's natural beauty and all
- 4 natural resources, including land, water, air, minerals and
- 5 energy sources, and shall promote the development and
- 6 utilization of these resources in a manner consistent with their
- 7 conservation and in furtherance of the self-sufficiency of the
- 8 State." Article XI, section 3 of the Hawaii State Constitution
- 9 further specifies that the State is obligated to "conserve and
- 10 protect agricultural lands, promote diversified agriculture,
- 11 increase agricultural self-sufficiency and assure the
- 12 availability of agriculturally suitable lands."
- 13 The legislature further finds that statute allows the
- 14 creation of conservation easements to effectuate this
- 15 constitutional mandate as conservation easements may be created
- 16 to preserve and protect land for agricultural use. The State
- 17 has also enacted ambitious mandates for the purchase of locally

- 1 produced food. Act 175, Session Laws of Hawaii 2021, requires
- 2 thirty per cent of the food that the department of education
- 3 serves in public schools be locally sourced by 2030, and
- 4 Act 176, Session Laws of Hawaii 2021, requires that fresh local
- 5 agricultural products and local value-added processed,
- 6 agricultural, or food products constitute at least fifty per
- 7 cent of the total produce purchased by state departments by
- **8** January 1, 2050.
- 9 The legislature also finds that the State must act
- 10 aggressively to meet these statutory mandates and to preserve
- 11 and protect agricultural lands to ensure that they are available
- 12 for future food production.
- Accordingly, the purpose of this Act is to appropriate
- 14 funds to the agribusiness development corporation to acquire a
- 15 conservation easement in central Oahu.
- 16 SECTION 2. There is appropriated out of the general
- 17 revenues of the State of Hawaii the sum of \$ or so
- 18 much thereof as may be necessary for fiscal year 2025-2026 and
- 19 the same sum or so much thereof as may be necessary for fiscal
- 20 year 2026-2027 for the acquisition of a conservation easement in
- 21 central Oahu.

- 1 The sums appropriated shall be expended by the agribusiness
- 2 development corporation for the purposes of this Act.

3 SECTION 3. This Act shall take effect on July 1, 2025
