### A BILL FOR AN ACT

RELATING TO STATE HOLIDAYS.

#### **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

SECTION 1. The legislature finds that 2024 marked the
 two-hundred thirty-fifth anniversary of the first arrival of
 Asian immigrant workers in the State. As of July 1, 2022,
 approximately 37.1 per cent of the State's population, over five
 hundred thousand residents, were of Asian descent.

6 The legislature recognizes that the Asian community in 7 Hawaii has made significant contributions to the State's social, 8 civic, and economic success, as well as its diverse and vibrant 9 culture, which includes the celebration of the Lunar New Year. 10 The Lunar New Year is joyously observed by numerous residents in 11 the State and is celebrated by more than two-thirds of Chinese, 12 Korean, Japanese, and Vietnamese Americans across the United 13 States. The Lunar New Year provides a time to renew one's 14 family ties; reflect upon the past year; and wish for good 15 fortune, health, and prosperity in the year ahead.

16 The legislature also finds that the United States House of 17 Representatives introduced resolutions recognizing the cultural

and historical significance of the Lunar New Year in 2021 and
 2023; California recognized the Lunar New Year as a state
 holiday in 2022; and New York recognized the Lunar New Year as a
 public-school holiday in 2023.

5 The legislature further finds that, by establishing the 6 Lunar New Year as a state holiday in Hawaii, the State can honor 7 its rich cultural history, demonstrate its commitment to 8 cultural diversity, and extend its best wishes for peace and 9 prosperity to all who celebrate this important occasion.

10 Accordingly, the purpose of this Act is to:

11 (1) Designate the day of the second new moon after the 12 winter solstice of each year as the Lunar New Year; 13 and

14 (2) Establish the Lunar New Year as a state holiday.

15 SECTION 2. Section 8-1, Hawaii Revised Statutes, is

16 amended to read as follows:

17 "§8-1 Holidays designated. The following days of each
18 year are set apart and established as state holidays:

19 The first day in January, New Year's Day;

20 The third Monday in January, Dr. Martin Luther King, Jr.,21 Day;
