### A BILL FOR AN ACT

RELATING TO FOOD SUPPLY.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

The legislature finds that the agricultural 1 SECTION 1. 2 sector serves as a cornerstone of the State's economy and 3 cultural identity by providing essential food products, employment, and sustainable land management practices that, when 4 managed properly, contribute to the State's overall food supply. 5 6 Although the State's livestock industry contributes 7 significantly to the State's food security and local 8 agricultural output, particularly through beef and pork 9 production, it also faces significant and substantial barriers 10 because of the limited number of licensed slaughterhouses in the 11 State that are capable of processing locally raised animals and 12 livestock. The legislature notes that California's production 13 of red meat from federally inspected and state inspected 14 slaughterhouses during December 2022 grew six per cent from December 2021, while Hawaii's production of red meat during 15 December 2022 fell eight per cent from the previous year. 16

1 The legislature recognizes that the number of animal 2 slaughterhouses in the State, and their respective capacities, 3 are limited. Notably, only one slaughterhouse on Oahu currently 4 slaughters hogs. The current lack of adequate slaughterhouse 5 facilities compels many local ranchers and farmers to either 6 ship their livestock to the continental United States for 7 processing, which can increase costs and environmental impacts from shipping and production, thereby decreasing the economic 8 9 potential for the State's agricultural producers and related 10 sectors.

The legislature further recognizes the importance of local 11 12 food sustainability and resilience as outlined in the Aloha+ 13 Challenge and other state initiatives that seek to increase 14 local food production and reduce reliance on imported foods. 15 The strategic development of additional slaughterhouse 16 facilities in the State would enhance the capacity of the 17 State's agricultural sector to meet these goals and provide 18 additional employment opportunities in the State.

19 The legislature further finds that the department of 20 business, economic development, and tourism is equipped with 21 expertise in infrastructure development, land use, and economic

planning and is well positioned to conduct a comprehensive, 1 2 data-driven evaluation of locations across the State that are environmentally, economically, and logistically suited for the 3 construction or expansion of slaughterhouse facilities. 4 А thorough assessment of these potential sites for slaughterhouse 5 6 development is appropriate to support the growth and sustainability of the local livestock industry, increase food 7 security, and contribute to the State's broader environmental 8 9 and economic goals, including contributing to the State's gross 10 domestic product through potential increases in profit margins 11 for local farmers, ranchers, and allied operators in the State. 12 Accordingly, the purpose of this Act is to: 13 (1)Require the department of business, economic development, and tourism, in collaboration with the 14 agribusiness development corporation, to identify 15 16 sites throughout the State that are suitable for the 17 development of slaughterhouses; and 18 Require the agribusiness development corporation to (2) 19 plan, design, construct, and operate new animal 20 slaughterhouses throughout the State.
