A BILL FOR AN ACT

RELATING TO THE LAPAKAHI MARINE LIFE CONSERVATION DISTRICT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the division of
- 2 aquatic resources (DAR) of the department of land and natural
- 3 resources issued a fishing moratorium in the waters surrounding
- 4 the Lapakahi state historical park. DAR intended for the
- 5 moratorium to restore overfished species, support the local
- 6 ecological balance, and honor the region's rich cultural and
- 7 historical significance. Studies conducted by DAR indicate that
- 8 fish populations in the Lapakahi marine life conservation
- 9 district have rebounded and coral health has improved since the
- 10 adoption of the moratorium. However, the moratorium has also
- 11 negatively affected local fishers and surrounding communities
- 12 that rely on these waters for their incomes and livelihoods.
- The legislature further finds that the moratorium on
- 14 fishing in the Lapakahi marine life conservation district is no
- 15 longer necessary as recent assessments indicate that populations
- 16 of key fish species have recovered. To address the economic
- 17 needs of the local community and to ensure the preservation of



- 1 the marine resources in the conservation district, fishing
- 2 should be reintroduced to the area under sustainable management
- 3 protocols. Reintroducing sustainable fishing practices with the
- 4 proper rules and regulations will benefit the local economy,
- 5 reinvigorate local fishing activity, and establish guidelines
- 6 for sustainable fishing to ensure that marine resources remain
- 7 available and plentiful. Lifting the moratorium will also
- 8 provide the local community with an opportunity to provide input
- 9 and collaborate with the department in the management of the
- 10 conservation district.
- 11 Therefore, the purpose of this measure is to direct the
- 12 department of land and natural resources to adopt rules lifting
- 13 the moratorium on fishing in the Lapakahi marine life
- 14 conservation district.
- 15 SECTION 2. The department of land and natural resources
- 16 shall adopt rules lifting the moratorium on fishing in the
- 17 Lapakahi marine life conservation district.
- 18 SECTION 3. This Act shall take effect upon its approval.
