A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that a local investorowned electric utility's planned public safety power shutoff 2 program, implemented on July 1, 2024, aims to reduce wildfire 3 4 risks by proactively shutting off power in high-risk areas 5 during specific weather conditions. While the program is 6 critical for public safety, its implementation poses significant operational challenges for public schools. Presently, fifteen 7 8 department of education schools and one public charter school 9 are identified as vulnerable to planned public safety power 10 shutoff events. These power outages may disrupt essential 11 services including communication systems, water access, meal 12 programs, and accommodations for students and staff that are 13 reliant on electricity-dependent medical devices or assistive technologies. 14

15 The legislature further finds that maintaining school
16 operations during planned public safety power shutoff events is
17 vital to ensuring educational continuity, providing access to

1 meals, and sustaining a sense of normalcy for students. This is
2 especially critical for students in remote or rural areas, where
3 schools often serve as essential community hubs. To meet this
4 need, schools must prepare for prolonged power outages by
5 implementing measures such as backup power solutions, access to
6 shelf-stable food and clean water, and fire safety protocols.

7 The devastating 2023 Maui wildfires underscores the 8 importance of preparedness and inter-agency coordination in 9 mitigating the impacts of emergencies and the United States 10 Department of Education's after-action report highlighted areas 11 for improvement, many of which align with the challenges posed 12 by the planned public safety power shutoff program.

13 Additionally, the department of education has implemented measures to support recovery and resilience for Maui schools 14 affected by the 2023 Maui wildfires. These include monthly 15 16 working group meetings to address fire mitigation, hazardous 17 brush clearance, and community engagement. Funds from the 18 project school emergency response to violence grant have been 19 allocated for critical recovery efforts, including mental health services, transportation for displaced students, and substitute 20 21 teachers to support staff well-being.

1 The legislature recognizes that lessons learned from the 2 2023 Maui wildfires and the department of education's subsequent actions provide a strong foundation for addressing the 3 challenges of the planned public safety power shutoff program. 4 5 However, additional funding is essential to implement long-term б solutions, such as establishing regional hubs equipped with 7 emergency supplies, procuring backup power sources, and providing comprehensive training for staff. These efforts will 8 9 ensure schools can remain operational during planned public 10 safety power shutoff events, safeguarding the well-being of 11 students and staff while maintaining access to essential 12 services. Through increased funding for schools impacted by the 13 planned public safety power shutoff program, the department of 14 education can assess the viability of using alternative power 15 solutions, such as generators and solar battery systems, for 16 planned public safety power shutoff identified schools; establish regional resource hubs equipped with essential 17 supplies, including water, shelf-stable food, and backup 18 communication tools, to ensure continuity of operations during 19 20 outages; provide training and develop contingency plans to 21 enable schools to remain open and safe during power outages; and

enhance fire safety measures and accommodations for students and
 employees with electricity-dependent needs.

Accordingly, the purpose of this Act is to appropriate
funds to the department of education to support schools impacted
by a local investor-owned electric utility's planned public
safety power shutoff program.

7 SECTION 2. There is appropriated out of the general 8 revenues of the State of Hawaii the sum of \$1,000,000 or so much 9 thereof as may be necessary for fiscal year 2025-2026 and the 10 same sum or so much thereof as may be necessary for fiscal year 11 2026-2027 for the department of education to support schools 12 impacted by a local investor-owned electric utility's planned 13 public safety power shutoff program.

14 The sums appropriated shall be expended by the department15 of education for the purposes of this Act.

16 SECTION 3. This Act shall take effect on July 1, 2025.
