A BILL FOR AN ACT

RELATING TO ORGANIC WASTE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the State did not
- 2 reach mandates established in 1991 to reduce the solid waste
- 3 stream by fifty per cent by 2000. The legislature also finds
- 4 that the Aloha+ Challenge established the goal to reduce by
- 5 seventy per cent the solid waste stream prior to disposal by
- 6 2030 through source reduction, recycling, bioconversion, and
- 7 landfill diversion methods for organic waste.
- 8 To meet United Nations Sustainable Development and Aloha+
- 9 Challenge goals related to waste reduction, there is a need to
- 10 embed in statute existing goals and further benchmarks to track
- 11 and require progress toward reducing solid waste production and
- 12 increasing organic waste diversion.
- 13 SECTION 2. Chapter 342G, Hawaii Revised Statutes, is
- 14 amended by adding a new section to be appropriately designated
- 15 and to read as follows:
- 16 "\$342G- Benchmarks. It is the goal of the State to
- 17 reduce the solid waste stream prior to disposal by requiring

1 SECTION 3. Section 342G-1, Hawaii Revised Statutes, is amended by adding two new definitions to be appropriately 2 3 inserted and to read as follows: 4 ""Biodegradable" means capable of being broken down or decomposed into carbon dioxide, methane or simpler organic 5 6 compounds by bacteria or other living organisms. 7 "Organic waste" means any material that is compostable or 8 biodegradable and is derived from either a plant or an animal, 9 and includes green waste, food waste, food-soiled paper that is 10 acceptable for food storage, and untreated and unpainted wood 11 waste." 12 SECTION 4. Section 342G-3, Hawaii Revised Statutes, is 13 amended to read as follows: 14 "[+]\$342G-3[+] Goals. (a) It is the goal of the State to 15 reduce the solid waste stream prior to disposal by: 16 (1) [Twenty-five] Forty per cent by January 1, [1995;] 17 2027; and 18 (2) [Fifty] Seventy per cent by January 1, [2000;] 2032; through source reduction, recycling, organic waste landfill 19 20 diversion, and bioconversion. Where feasible, the office shall

- 1 establish other state goals for specific commodities,
- 2 recognizing market considerations.
- 3 (b) It is the goal of the State to reduce [by not-less
- 4 than twenty-five per cent the amount of office paper generated
- 5 by all state and county agencies by January 1, 1995, through
- 6 source reduction. The base year for calculating progress toward
- 7 this goal shall be total office paper consumption by state and
- 8 county agencies in 1990.] organic waste stream disposal via
- 9 incineration, waste-to-energy, or landfill by:
- 10 (1) Forty per cent by January 1, 2027;
- 11 (2) Seventy per cent by January 1, 2032; and
- 12 (3) One hundred per cent by January 1, 2037.
- 13 (c) Nothing in this chapter shall be construed to restrict
- 14 a county from setting waste reduction goals higher than those of
- 15 the State."
- 16 SECTION 5. Section 342G-26, Hawaii Revised Statutes, is
- 17 amended by amending subsection (c) to read as follows:
- 18 "(c) The recycling [and], bioconversion, and organic waste
- 19 diversion component shall identify and assess:
- 20 (1) The level of waste reduction the county is achieving
- 21 through existing recycling and bioconversion efforts;

DOH; Counties; Solid Waste Reduction; Organic Waste Diversion; Benchmarks; Appropriations

Description:

Establishes statewide goals for solid waste reduction and organic waste diversion. Requires each county to incorporate into its next integrated solid waste management plan revision a plan to reduce all organic waste produced within the county by facilities generating more than a specified amount of organic waste per year in alignment with established state benchmarks. Appropriates funds.
