A BILL FOR AN ACT

RELATING TO POLOLU VALLEY MANAGEMENT EFFORTS ON HAWAII ISLAND.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that Pololu Valley, on 2 the northern coast of Hawaii island, is a place of unparalleled 3 natural beauty, characterized by its lush landscapes, diverse 4 flora and fauna, and cultural significance to Native Hawaiians. 5 Pololu Valley serves as a vital ecosystem, providing habitat to various endemic and endangered species, contributing to the 6 7 region's ecological balance, and offering invaluable 8 opportunities for scientific research and environmental 9 education. ÷

10 The legislature also finds that preserving and protecting 11 Pololu Valley is essential to safeguarding its unique 12 ecological, cultural, and historical attributes to benefit 13 present and future generations. Currently, high levels of 14 tourism produce a significant impact on the area. The lack of 15 nearby restrooms and visitor education efforts have contributed 16 to safety and litter issues, with plastics that are left behind 17 on the trail eventually washing up on the shoreline. active management, the condition of Pololu Valley will continue
 to deteriorate.

Accordingly, the purpose of this Act is to appropriate
moneys to the division of forestry and wildlife of the
department of land and natural resources for the management of
Pololu Valley, including various improvements necessary for
conservation and protection.

8 SECTION 2. There is appropriated out of the general
9 revenues of the State of Hawaii the sum of \$ or so
10 much thereof as may be necessary for fiscal year 2025-2026 for
11 Pololu Valley management and conservation, including:

12 (1) Development of the trailhead;

13 (2) Development of infrastructure necessary to accommodate14 parking;

15 (3) Installation of appropriate informational, historical,

16 and educational signage;

17 (4) Design and construction of restroom facilities;

18 (5) Establishment of full-time equivalent

19 (FTE) positions to manage the trail area during
